



PORTSMOUTH NH 400 GRAND PARADE Saturday, June 3 (rain or shine) 11:00am start

GENERAL PARADE RULES

- Walking, driving, bike riding, skate boarding, roller skating, dancing, and general merriment allowed.
- Smoking, alcoholic beverages, controlled substances, firearms, mini-bikes, segways, and 4-wheelers are prohibited.
- Bicyclists, skateboards & scooters must wear a helmet and maintain proper bicycle safety.
- Equestrian units may not be left unattended and must be followed by a clean up crew.
- Children must have adult supervision before, during and at the end of the parade. State law also requires there be at least one adult for every four children riding on a float.
- All vehicle operators must possess a valid driver's license and registration for the vehicle.
- Each entry application has a maximum number of vehicles at the parade organizer's discretion.

ROUTE

- For parade participants, the parade line up will be along Islington Street near Plaza 800/Goodwin Park. The week prior to the parade, all participants will be notified of their specific line-up location and time.
- The parade steps off from the Goodwin Park area on Islington and proceeds down Congress, through Market Square, right onto Pleasant, and right onto Junkins Ave.
- The route is 1 mile and will take apx 1.5 hours to process. Pre-parade line up is typically 30-min to 1-hour.
- End of parade is at South Mill Pond parking lot on Junkins Ave.

BEGINNING & END

- Beginning: Everyone must be in place by 10:30am. Units will be assigned a specific arrival time starting at 9:45am and location will be based on your position in the parade. Parade lines up along Islington Street.
- All entries must check in with volunteers wearing "Event Staff" shirt.
- No float or vehicle may be left unattended while waiting for the parade to begin. No idling.
- All vehicle operators must possess the proper driver's license and registration for the vehicle. Police will
 check prior to step off of the parade.
- End: South Mill Pond on Junkins Avenue.
- Volunteers will be at the end of the route to help direct and keep parade moving to avoid stalling.

PARKING: BEGINNING & END

- Parade officials are making arrangements for participant parking. Streets will be closed to parking so you will need to plan ahead. Closer to the parade participants will be informed of overflow lots and good drop off/pick up locations.
- We do not want to disrupt any local businesses more than we have to so please do not park in a business lot.
- There will be a Bike Valet station at the Middle School as well.

LIABILITY RELEASE

- Applicants assume all responsibility for any loss or damage in connection with their participation in the parade. Portsmouth NH 400 and the City of Portsmouth will not be liable for any damage, theft, loss of property, or injury.
- Portsmouth NH 400 and the City of Portsmouth reserve the right to remove any entry where safety measures are, in the opinion of staff and/or volunteers, inadequate.
- The ultimate responsibility for safety lies with each parade participant. Participants must comply with
 these rules and follow all other applicable government laws and regulations, safety codes, manufacturer's
 recommendations, and similar standards necessary to safely operate vehicles, floats and equipment.

FLOATS

- No floats or towed trailers with wheels protruding beyond the footprint of the float platform will be allowed. No exposed wheels. Fenders may not be sufficient. Be sure your float includes a platform that extends out farther than the wheels. If you have questions, call Brinn at 603-767-2697.
- Towed float trailers can be no longer than 23 feet long and flatbed trailers no longer than 29 feet. Floats shall be no more than 13 feet high from the ground and 9 feet wide.
- Participants SHALL NOT get on or off moving floats and walking participants SHALL NOT retrieve articles from floats.
- Portable generators must be securely mounted. Floats should be constructed with fire-retardant materials
 and must carry an all-purpose type ABC, 5-lb. fire extinguisher within reach of the driver. No open flames
 are permitted.
- At least one adult, other than the driver, must supervise children riding on vehicles and have a reasonable means of immediate communication with the driver. There "shall not be less than one adult per every 4 children and sufficient to ensure each child is visible to a supervising adult," per RSA 265:108-a.
- All participants on floats must be seated with a substantial barrier in front of them; sitting on the edge of the vehicle/float with arms and legs hanging off is prohibited.
- Standing participants must wear a safety belt to prevent falls from the float or vehicle.
- The name of the float-sponsoring organization must be visible to the crowd. Commercially sponsored floats must promote PNH400 theme/fun feeling/Portsmouthy-vibe and not emphasize commerce.
- For Floats, here are 3 tips:
 - 1. If pulling a trailer-- wheels must not be exposed (platform must go further out than wheels).
 - 2. Vehicle and trailer must be registered and insured. Police may ask at parade line up.
 - 3. Valid driver's license of the driver of the float unit must be with driver at all times.

CANDY & HANDOUTS – NOT ALLOWED

Parade participants are asked NOT to distribute candy, handouts or souvenirs along the parade route. The parade must consider the amount of waste it might create during normal operating hours of local businesses and the clean up crew.

FEES

There is no cost to participate in the parade. Everyone is welcome. However, please keep in mind that this is a community event and not to be treated as a solely commercial opportunity. Registration required.

RAIN This is a rain or shine event. In the event of inclement weather, please dress accordingly. If the weather is more serious, parade officials will make an announcement on their social media pages.

IMPORTANT DEADLINES

Mon, May 15 (trailers, floats)

Registration deadline for floats, flatbed trailers, towed trailers. There will be a mandatory Float Safety Meeting: Date to be determined. Please submit 3 things to us before, and bring copies to the meeting:

- 1. Pics or schematics of float (if pulling a trailer-- photos must show that wheels are not exposed)
- 2. Proof of registration & insurance for trailer
- 3. Photocopy of the driver's license of the driver of the float unit.


Mon, May 15 (Marching Bands) Registration deadline. Include # of school buses anticipated, any trailers, etc.

Mon, May 22

Deadline for all other entries. All units must be pre-registered to participate in the PortsmouthNH400 Parade.
