About the Summit

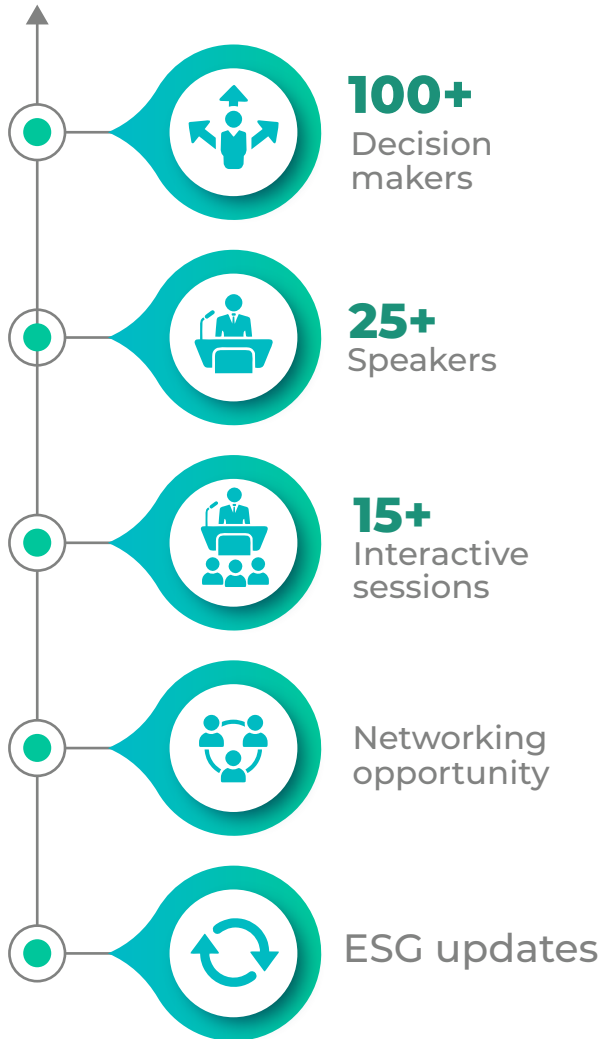
