Message from our Founder

Dear friends,

In some ways, this special Annual Impact Report is one big "thank you" to everyone who has believed in the mission and vision of Magnified Giving for the last 15 years. We're saying "thank you" for helping us educate 42,009 youth in philanthropy since 2008 and support local charities with \$1.5 million in youthgranted funding in the process.

When I started Magnified Giving in 2008, that first year, we empowered students from 8 schools to give away \$8,000 to local charities. In 2008, I guessed and hoped and dreamed that if you engaged youth in philanthropy, they would be more likely to engage in their communities as adults. Back then, I hoped. 15 years later, I know. Now, I know that this process has both short and long-term benefits for youth. I know that when we teach youth how to use their time, talent, and treasure to serve others, they are more likely to pursue careers in the nonprofit sector, volunteer and donate regularly, and be active and engaged citizens in their communities. I've learned this from Taylor Young, the recipient of the 2023 Bill Keating Jr. Next Gen Award, who says her experience in Magnified Giving compelled her to pursue a nonprofit career. I've learned this from Julie Gyure, a former participant who went on to help us develop Camp Give and now serves on our Board of Directors and volunteers regularly at her local Ronald McDonald House. I've learned this from Carter Flora, a recent graduate of Turpin High School, who told me that his 4 years in Magnified Giving gave him unbeatable opportunities to grow as a leader and develop a deep-rooted connection with a local nonprofit, Luke5Adventures. He's heading to OSU this fall excited to seek opportunities to continue his philanthropy journey.

I know that sometimes, what we do at Magnified Giving seems complicated. But to me, it's so simple. When we let our gifts pass through the hands of youth before reaching worthy nonprofits, our gifts are magnified in the lives of young people like Taylor, Julie, and Carter. Thank you, from the bottom of my heart, for letting us magnify your gifts. Let's keep going.

The Power of Student Advocacy: Elder High School's Impactful Philanthropy Program



Since 2008, Magnified Giving has educated 42,009 young people through our Youth Philanthropy Programs. In 2008, we facilitated programs in 8 private schools, and youth chose 8 grant recipients to receive \$8,000 in grant funding. During the 2022-2023 school year, youth in 124 programs granted \$185,989 to 127 community nonprofits. In 15 years, we've expanded access to these meaningful programs not only to public schools, but also to youth development programs beyond the classroom where we are able to reach at-risk youth and young adults with special needs with the powerful benefits of service-learning.

For example, during the 2022-2023 school year, we partnered with the University of Cincinnati Transition & Access Program to engage young adults with mild to moderate intellectual or developmental disabilities in philanthropy. These youth passionately explored social causes and nonprofits that interested them, and they made posters and presentations to educate their fellow students and UC community members. They also volunteered at all the organizations they advocated for. Together, they chose to grant \$1,000 to Inspiration Studios, an organization that provides innovative programming for individuals with developmental and intellectual disabilities. They also granted \$250 each to Buddy Up for Life and Luke5Adventures.

CAMP GIVE

Fun, energetic summer service-learning camps for 5th-9th grade students to engage in meaningful hands-on service projects and learn how they make a difference in the world.

Camp Give 2023 was our best year of summer philanthropy camps yet! This year, 44 5th-9th graders participated in 4 different weeks of Camp Give. For the first time, we hosted camps at the Evendale Recreation Center, a space that provided new opportunities to play, learn, and serve, and to engage with nearby community members and partners, including the Evendale Fire Department.

Each day, campers visited a nonprofit partner to learn about their mission and work together on a service project. At the end of the week, they granted a portion of the their camp fee to the nonprofit that interested them most! In addition to opening their hearts and minds to community needs, they often learned new skills! For example, at New Life Furniture Bank, campers used donated wood scraps to build end tables for families in need.

We provide resources to infuse our region with and engage youth in service-learning and encourage meaningful conversations about philanthropy and service.





Service-learning is a proven instructional strategy where youth use academic skills and knowledge to address real community needs. It's known to improve academic outcomes while introducing youth to meaningful, hands-on opportunities to develop 21st century skills and find thoughtful solutions to needs in their schools and communities. Many of the teachers who facilitate the Magnified Giving Youth Philanthropy Program in their classrooms utilize the principles and process of service-learning, and we encourage this overlap because of the proven benefits of service-learning for youth, educators, schools, and communities. Magnified Giving offers resources to all educators, including one-on-one consultation, to support robust service-learning practices.


