

# Terms & Conditions

## Part A – FLX sign-up offer competition November 2022

1. These "terms & conditions" contained in Part B apply to the Competition of chance described in Part A. Capitalised terms not otherwise defined in this Part B will have the meaning given to them in Part A.
2. The Competition will be conducted by the Promoter during the Competition Period specified in Part A.
3. The Terms may be amended or replaced by the Promoter in its absolute discretion and at any time. Any amended terms will be posted online at [www.flexischools.com.au](http://www.flexischools.com.au).
4. Entry into the Competition as described in Part A is deemed acceptance of the Terms (as amended from time to time).
5. Entry is open only to permanent residents of Australia who comply with the additional entry restrictions specified in Part A.
