**CANCELLATION POLICY:** Free cancellations up to 5 days before scheduled booking date, 50% refund for cancellations between 2-5 days before scheduled date. Cancellations within 2 days prior to scheduled date are Non-refundable.

**WATERCRAFT USE:** The RENTER understands that conditions (Weather, Water Levels, Water Conditions etc.) Are variable RENTER must exercise caution, pre-planning and use good judgment in use of watercraft.

RENTER also acknowledges and understands that state laws and local water laws are to be followed at all times during the duration of the rental.

RENTER also acknowledges and understands that operation of the boat or equipment rented, it is ILLEGAL to operate equipment while under the influence of any alcohol or drugs.

RENTER also acknowledges and understands that any aged 13 or younger must wear USCG approved life vest at all during the duration of the rental.
