Another Perspective Foundation Scholarship Regulations

§ 1. General Provisions

1. These regulations define the terms and conditions for awarding scholarships by the Another Perspective Foundation (hereinafter referred to as "the Foundation") to Palestinian youth who are in Poland or arriving in Poland, including those applying for studies in Poland or already studying in Poland.
2. The aim of the Scholarship is to support the educational and developmental needs of Palestinian youth, increasing their chances of realizing their professional and academic goals in Poland.
3. The number and amount of scholarships depend on the success of fundraising campaigns conducted by the Foundation.
4. The Foundation's Executive Board decides on the selection of scholarship recipients and the amount of scholarships awarded. The Board may decide to grant smaller scholarship amounts than applied for, depending on the available funds and the number of applicants.

§ 2. Participants

1. Individuals who meet the following criteria may apply for the scholarship:
 - a. are of Palestinian origin,
 - b. are applying for studies in Poland or are already studying at a Polish university,
 - c. Candidates must demonstrate motivation for learning, commitment to personal and professional development, and a need for financial support.

§ 3. Applications

1. Scholarship applications must be submitted using the form provided by the Foundation.
2. The application form must be completed fully and correctly, including all required information and documents that verify the fulfillment of participation criteria.
3. The Foundation will announce the deadline for submitting applications in an appropriate notice.
4. The scholarship may only be allocated for the following purposes:
 - a. Living expenses,
 - b. Tuition fees,
 - c. Educational materials.

§ 4. Selection Process

1. Applications are verified for compliance with participation criteria and completeness of the submitted information.
2. Based on the responses in the attached form, the Foundation's Executive Board conducts a preliminary selection of candidates.



3. Candidates selected in the preliminary selection process will be invited to meet with the Foundation's Executive Board to make a final decision on the awarding of the scholarship. This meeting aims to better understand the candidates and their needs.
4. The final decision on awarding the scholarship is irrevocable.
5. The decision to award the scholarship will be announced directly to the scholarship recipient.

§ 5. Scholarship Payment

1. The scholarship is paid either in one lump sum or in installments, depending on individual agreements with each scholarship recipient.
2. The scholarship payment is made to the bank account specified by the scholarship recipient.

§ 6. Scholar's Obligations

The obligations of the scholarship recipient include:

1. Informing the Foundation of any changes in their education plan.
2. Participating in events organized by the Foundation for the official awarding of the scholarship.
3. Cooperating in promoting the Foundation's activities by publishing at least one post about the scholarship on their social media profile.

§ 7. Loss of Rights

1. An applicant loses the right to the Scholarship if they:
 - a. lose legal capacity,
 - b. are placed under guardianship,
 - c. receive a final conviction for a crime or misdemeanor,
 - d. do not participate in the meeting with the Board,
 - e. do not have a bank account required for the scholarship payment,
 - f. are awarded the Scholarship based on false information,
 - g. commit plagiarism in the application,
 - h. do not claim the Scholarship within 14 days from the announcement of the results,
 - i. renounce the Scholarship,
 - j. commit other verification breaches.
2. Anyone who has already received the scholarship amount when any of the conditions mentioned above are updated is obliged to return the scholarship amount under general rules within 14 days from the occurrence of the condition.
3. If the condition specified in § 7.1(h) is updated, the Foundation's Executive Board will introduce a special procedure for selecting another person who was closest to obtaining the Scholarship status according to these Regulations.
4. There is no appeal against the decision to lose the right to the Scholarship.

§ 8. Personal Data



1. The administrator of personal data processed in connection with the Competition, through which the Scholarship is awarded, is the Foundation.
2. The processing of personal data of Candidates and third parties nominating Candidates along with the image of the Candidate is to conduct the Scholarship Competition and Scholarship payment.
3. The personal data and image of the Scholarship recipient will be used for marketing, promotional, or publication purposes by the administrator for the period necessary to fulfill claims.
4. Recipients of the data provided by Candidates are only employees of the Foundation.
5. Consent to the processing of personal data covers the period of the Scholarship edition, i.e., 2024-2025. For the Scholarship recipient, consent includes processing their personal data and image after the end of this Scholarship edition.
6. The processing of personal data provided based on the application form is based on consent under GDPR, included in the Application in the application form.
7. Processing of the image is based on the consent given by the Candidate in the application form.
8. Consent is voluntary but is a necessary condition for participating in the Scholarship Competition.
9. After the end of this Scholarship competition, the personal data of the Candidates will be deleted. This section does not apply to the Scholarship competition winner.
10. Candidates have the right to access their personal data, the right to rectify, transfer, delete, limit processing, and object to processing.
11. Candidates have the right to lodge a complaint with the supervisory authority - the President of the Personal Data Protection Office.
12. The data provided by Candidates will not be used for automated decision-making and will not be profiled.
13. The Foundation, as the data administrator, ensures that all necessary organizational and technical measures are taken to protect personal data.

§ 9. Tax

1. The Another Perspective Foundation hereby informs that, in accordance with the applicable tax laws in Poland, certain forms of scholarships may be subject to taxation as the recipient's income. In the event that the awarded scholarship is subject to taxation, the Foundation reserves the right to deduct the appropriate amount of tax from the scholarship awarded before it is paid out to the scholarship recipient. The amount of tax deducted will be in accordance with the current income tax rates for individuals, as per the Act on income tax from individuals.
2. The Foundation commits to providing the scholarship recipient with the appropriate documents confirming the amount of tax deducted, which can be used by the scholarship recipient for settlement purposes with the relevant tax office.
3. The scholarship recipient is obliged to familiarize themselves with the applicable tax laws and to independently settle any potential tax, should the situation require it. The Foundation recommends consulting with a tax advisor



to fully understand the tax obligations associated with receiving the scholarship.

4. The Another Perspective Foundation does not bear any responsibility for the individual tax obligations of the scholarship recipient that may arise from the awarding of the scholarship.

§ 10. Final Provisions

1. The Foundation reserves the right to amend these regulations. Any changes will be communicated to participants appropriately.
2. Matters not regulated by these regulations are decided by the Foundation's Executive Board.
3. Providing false information in the application process is strictly prohibited and results in immediate exclusion from the selection process without the possibility of appeal.
4. These regulations come into effect on the date of announcement.
