### **LOCATION CONTRACT**

I give permission to [Production Company] and its employees, agents, contractors, suppliers, successors and assigns ("The Company") to enter upon and use the property (properties): We will be for the purpose of photographing, filming and recording (including sound recording) certain scenes for inclusion in television commercial for The Company may use the premises until all scenes requiring the location have been completed on the above referred dates. The Company will have the right to use the property for additional filming as may be necessary and payment will be prorated from the charges listed below.

The Company may place all necessary facilities and equipment on the property and agrees to remove them after completion of the work and leave the property in as good condition as when received. Signs on the property may, but need not, be removed or changed, but, if removed or changed, the Company will replace them.

The Company agrees to use reasonable care to prevent damage to the property and will indemnify the Owner and all other parties lawfully in possession of the property, and hold each of them harmless from any claims and demands of any person or persons arising out of, or based upon, personal injuries, death or property damage suffered by such person or persons resulting directly from any act of negligence on the Company's part in connection with this project.

All rights of every kind in and to all photographs, sound recordings and any other film made on the property shall be and remain vested in the company and neither the Owner nor any tenant or other party having an interest in the property shall have any right or action against the Company or any other party arising out of any use of the photographs, film and/or recordings.

You warrant and represent that you have the right to enter into this contract agreement and to grant the Company all rights provided by this contract including, without limitation, the right to photograph and film and to broadcast the photographs and films of the premises and any and all furnishings, works of art and other objects located in or around the premises.
