- ✓ Thank you to our volunteer coaches, team staff, division managers and tournament organizers.






C Division:

INNOVATIVE & INCLUSIVE APPROACH TO PLAYER SAFETY, DEVELOPMENT & EVALUATION

- ✓ Player safety includes renewed focus and accountability on safety in the changing room,
- Continue to develop and expand the Mental Health Week initiative,
- Re-ignite plans in PCAHA on non-contact competitive recreational hockey options,
- Diversify and improve Semiahmoo Ravens Hockey goaltending instruction options,
- Implement a strategy for recruitment and retention of goalies,
- Continue to improve efficiency and transparency of player evaluations,
- Maximize coach support, increased mentorship, better online tools, maximize use of player development leads,
- ✓ Continue to maximize revenue development through camps and clinics etc. to offset any fee increases and sustain funding for initiatives.

- ✓ Work with PCAHA and BC Hockey to help coordinate marketing and telling the minor hockey story to increase recruitment and retention, combat rise of unsanctioned programs and promote the positive attributes of association hockey,
- ✓ Work toward expanding high school partnerships to offer increased programming and promotion of Semiahmoo Ravens Hockey with local elementary & secondary schools,
- ✓ Connect with alumni, refresh hockey relationships with local WHL and Junior A & B clubs,
- ✓ Build on Ravens identity, supporting teams, volunteering in the community, refresh community, media strategy & overall communications,
- ✓ Providing scholarships, securing sponsorships & fundraising in our community,
- ✓ Secure a new Ice facility We need a rink for our community!





Treasurer Report to Members:

- ✓ 2020/21 saw a \$63k surplus after two years of deficits relating to our investment into our development program
- ✓ Budgeting for 2021/22.
 - ✓ COVID still out there uncertain what season might look like
 - ✓ Will a year of no games impact registration #'s?
 - ✓ Will games return?
 - ✓ Will camps registration numbers be capped again?
 - ✓ Where will ice costs go?
 - ✓ Will government support continue?
 - ✓ Many families still feeling financial effects of COVID
 - ✓ Registration fees were frozen for 2021/22
 - ✓ Budgeted for an \$18k deficit for 2021/22

2021/22 operating results (continued)

- ✓ General & Administrative expenses up \$12k (\$210K to \$222K vs \$225 pre-covid),
- √ \$150k gaming grant from province (~\$160/child),
- ✓ Received \$38k of government assistance under COVID support programs total of \$84k over two seasons,
- ✓ Overall surplus of \$99k vs budgeted deficit of \$18k:
 - √ + 37k of registration revenue
 - √ + 45k of COVID support (government and ViaSport)
 - √ + 54k under ice budget.

Balance sheet highlights at March 31, 2022

- \$375k cash balance vs \$291k at March 31, 2021
- \$11k in accounts receivable relates to team fees paid after year-end (prior year \$49k which included \$34k rebate from BC Hockey)
- \$44k in deferred revenue => relates to \$20k of sponsorship for 2022/23 season and \$24k of spring program revenues collected before year-end
- Long-term debt repaid in March => related to \$60k federal covid support loan (\$20k of forgiven)
- \$318k surplus at March 31, 2022

Looking forward into 2022/2023

- 2022/23 budget highlights:
 - Continued focus on cost/financial controls,
 - Expect inflation to creep into many of our costs,
 - Targeting a \$300k cash reserve (2 years of historical gaming grant),
 - Registration fees increase about 5%,
 - Budgeted a \$65k deficit for season.
- Some early insight to 2022/23 financial results:
 - Registration on target,
 - Summer camp a success,
 - \$168,400 gaming grant received.






