



Europa Partners Receives Seed Investment from Galaxy Digital

Investment enables Europa Partners to scale institutional actively managed strategies focused on crypto

NEW YORK, July 28, 2022 - [Europa Digital Assets Ltd.](#) (“Europa” or “the Firm”), an active alternative investment manager focused on crypto opportunities, today announced that it will enter into a partnership with an affiliate of Galaxy Digital Asset Management (“GDAM”), the diversified asset-management arm of [Galaxy Digital Holdings Ltd.](#) (TSX:GLXY) (“Galaxy Digital”) that is dedicated to the digital assets and blockchain technology industry.

GDAM’s investment will provide seed capital for the Firm’s Europa Opportunistic Offshore Fund, a newly launched fund that will offer investors exposure to cryptocurrency markets by actively managing investments across the digital asset ecosystem, including spot assets, derivatives, and DeFi protocols. Europa will also utilize Galaxy Digital’s trading platform. Additional terms of the partnership weren’t disclosed.

Leading Europa is a seasoned team of trading, investment, and technology professionals whose experience spans both traditional finance and the ever-growing digital asset economy. Europa is managed by Co-Founders Peter Wisniewski, who was formerly Co-Head of Global Trading at Galaxy Digital, and Sarah Olsen, who was previously Head of Corporate Development for Onyx by JPMorgan.

“An active, nuanced investment approach to digital assets can help investors navigate choppy market conditions and a challenging macro environment,” said Damien Vanderwilt, Co-President of Galaxy Digital. “We are excited to continue our relationship with Pete, who was integral in building and implementing Galaxy’s trading platform, and look forward to partnering with him, Sarah, and the entire Europa team in this expansion of GDAM’s capabilities.”

“Galaxy’s support is a strong show of confidence in our vision to unlock actively managed exposure to the crypto markets with institutional oversight and risk management,” said Olsen. “Galaxy’s suite of institutional services and infrastructure will provide us with tremendous leverage to ensure best-in-class operations and fund management for investors in the sector.”
