****Vendor Set-Up Instructions****

You will enter the setup area at the flagpole – this is the best point of entrance. For exit, we will have the two areas circled in red available as well, though those are trickier exits (blind hill on either side). We are happy to help with traffic for exit when you're prepared. Please feel free to leave once you've run out of supplies, unless you'd rather stay for the fireworks, in which case, please hang out!

If anyone has an extra trailer or other additional setup things that they will not need DURING the festival necessarily, we have additional storage available at the farmhouse directly across the road from where we will be having the festival. Please communicate with me (Michelle) if that is something you'd like to take advantage of so we can assist.

****VERY IMPORTANT POINTS BELOW****

VENDOR SITE RULES: Absolutely no alcohol, cigarettes, vape products, E-cigarettes, chewing tobacco, marijuana (medicinal or not). No weapons can be bought or sold.

CASH ONLY VENDORS – IF YOU ONLY ACCEPT CASH, YOU **MUST** HAVE A SIGN NO SMALLER THAN 24"x36" STATING "CASH ONLY"! Last year, patrons stood in line for hours only to find out that some vendors were not accepting credit or debit cards. We do not want that to happen again this year.

PRO-TIP FOR TRAFFIC CONTROL – For food vendors especially, I would highly suggest bringing a traffic cone or pole with a rope to designate your line and even display your menu/FAQs for those at the back of the line. In years prior, lines have been extremely long and if you're able to provide clarity and information for your patrons who are waiting, it will go a long way in terms of client satisfaction.

<u>PAYMENT</u> – Due IN FULL at time your application is received. No space(s) will be reserved without payment. Payment by check will need to be made in person at the Spring Valley Farms office location.

NOTE: FEE IS NONREFUNDABLE FOR LATE ARRIVALS OR NO SHOWS.

PROOF OF INSURANCE – I will need a certificate of insurance (COI) from each vendor listing "Spring Valley Horse Farm LLC" and "Garland and Carolyn Simmons" as additional insured. Please email this to me no later than 10 days prior to the scheduled event.

<u>ASSIGNED SPACES</u> – This year, I have thoughtfully designated spaces for each vendor to maximize traffic flow and exposure for <u>all</u> vendors. Please do not just pull in and set up anywhere! The final site map will emailed closer to the event date and spots will be laid out so setup should be a breeze. If you have any questions, call or text me at (434) 841-4188 the day of setup for directions. Electric hookups will not be available. Tables, chairs or tents will not be supplied. Vendors are encouraged to bring pop-up canopies, generators, etc., as needed. Access will be available for water to fill up a bucket if needed.

SETUP TIME – the festival doesn't actually begin until 5PM but we always have a wave of early birds so I am encouraging everyone to be physically present no later than 2:00pm. It is your prerogative of course if you'd rather come a little later, but please be warned that you may miss out on a wave of early clients and there may be significantly more congestion as well. Setup times are between 10:30am – 4:00pm. **Please do not arrive earlier than 10:30am.** Food Trucks please try and setup between 10:30am – 1:00pm.

NOTE: NO ONE WILL BE ALLOWED TO SETUP AFTER 4:30PM.
