These mainstream tax preparation software systems were evaluated by drawing upon wisdom from the Luminary Evaluation Group's <u>Confidence in Quality Tax Prep Rubric</u>, the Home Grown <u>Preparing for the 2022 Tax Season Guide</u>, and CS' extensive coaching with child care providers on the topic of tax education. The following features were taken into consideration as essential for impacting the child care business owner's tax preparation experience:

- 1. **Usability** how easy the user interface is to use and navigate.
- 2. **Guidance** how informative the system is, providing examples and explanations of terminology and deductions.
- 3. **Business Use of Home** the accuracy and process of guiding providers through the calculation of this key deduction for family child care homes by applying their time-space percentage to business expenses.
- 4. **Meals** the accuracy and process of guiding providers through the calculation of this key deduction for child care businesses that serve children meals.
- 5. **Depreciation** the process of guiding providers through the calculation of this key deduction for child care businesses.
