#### Course Description:

This 4 day course includes over three days of instruction on theory, software tool operation, and case studies, with the exam on the fourth day (four-hour comprehensive exam). Students achieving a passing mark (80%) will obtain AEP certification and a certificate number registered at AEP for submitting SST derived SRGs. The course will include instruction on the newest Version 3.0 (build 3.0.1) including the subsoil SAR/sodium module, along with some comparisons to the previous version to provide context for the numerous updates/upgrades in Version 3.0. Successful completion of the course including passing the exam will result in SST certification allowing the formal submittal of SST assessments.

#### **Course Prerequisites:**

Knowledge of Alberta Tier 1 and Tier 2 guidelines for soil and groundwater is required, with a focus on salinity guidelines. A basic understanding of soil and groundwater physical and chemical properties is highly recommended. Good working knowledge of Microsoft Excel on Windows computers is required as part of case study data analysis and assessment with the SST during the course. SST software installation and User Manual review prior to attending the course will assist in achieving a passing mark - this is highly recommended as the course instruction duration and pace has been designed with the assumption that pre-course review has been completed by students. Recently-released build 3.0.1 will be used, which includes some minor big fixes and updates from the previous 3.0.0 release.
