- Imagine what it would be like to be your favorite animal.
- Describe the best, funniest, or weirdest day you've ever had.
- Share a story about you and your friend.

Children's Online Privacy Protection Act (COPPA) Privacy Notice

Children's Online Privacy Protection Act (COPPA) requires that we gain verifiable consent for your child to participate in this contest. We are asking for your permission to retain your child's information (first name and last initial, age, parent/guardian first and last name, primary phone number, and email address) for the purpose of monitoring the program participation, for allowing contest entries and content submissions, for notifying contest winners. If you consent, we may use your child's name, grade, and school to promote the contest.

Dear Parent/Guardian,

Your child has entered the 2024 Symphonic Story Time: Stories by Classic City Kids Challenge, an opportunity for children to submit a story which could be selected to be set to music and included in Quintet Athens Symphony Story Time: Stories by Classic City Kids concert in June of 2024. For the contest, we are asking for you to provide your child's information (first name and last initial, age, grade, school, as well as parent/guardian's first and last name, primary phone number, and email address) and their story for the Symphonic Story Time: Stories by Classic City Kids Challenge. Since your child is under the age of 13, the information collected will be kept confidential in compliance with COPPA and other similar state and federal laws. Quintet Athens is the only organization that will have access to your information during the contest.

- The personal information provided by the child is used for monitoring the program participation, for allowing contest entries and contest submissions, for notifying contest winners, and handing out prizes.
- Only with parent/guardian consent the child's name, age, grade, and school may be used to promote the contest. This includes but is not limited to promotion on social media, websites, etc.
- The operator will not require a child to disclose more information than is reasonably necessary to participate in the contest as a condition of participation.
- No information will be disclosed to third parties; this means that information will not be shared with any businesses and/or added to any mailing lists.
