**MAYORS AND LOCAL ELECTED LEADERS FROM ACROSS THE U.S. SEND LETTERS TO TEXAS ATTORNEY
GENERAL: GUARANTEED INCOME WORKS**

(Washington, DC) – Leaders of Mayors for a Guaranteed Income (MGI) and Counties for a Guaranteed Income (CGI) have been sending letters to the Attorney General of Texas in response to his lawsuit against the guaranteed income program in Harris County. MGI Co-Chairs **Michael D. Tubbs** and **Mayor Melvin Carter** of Saint Paul, MN, CGI Co-Chairs **Toni Preckwinkle**, President of the Cook County Board of Commissioners, and **Holly J. Mitchell**, Los Angeles County Supervisor, have all sent letters, as well as Mayors & County leaders from **Albuquerque, NM; Baltimore, MD; Bell Gardens, CA; Cambridge, MA; Cudahy, CA; Santa Clara, CA; Tacoma, WA; and Yellow Springs, OH**. The Texas Supreme Court will decide the fate of Uplift Harris, the guaranteed income pilot in Harris County, where Houston is located, after State Attorney General Ken Paxton filed a [lawsuit](#) to stop the program. This is the first time a guaranteed income program in Texas has been attacked by the state, and it comes after Texas lawmakers tried and failed, twice, to pass legislation banning guaranteed income.

[Austin](#) and San Antonio have previously offered guaranteed income programs in Texas. Dallas is giving 500 residents making \$14,000 per year a \$250 check every month. El Paso County is set to roll out its own guaranteed income program later this year. No lawsuits have been filed against these programs.

Houston is the fourth largest city in the U.S., with a diverse population calling the city home. If effective, this lawsuit could serve as a model for opponents in other states to ban guaranteed income programs. Currently there are around 150 guaranteed income pilots operating in at least 27 states.
