Oregon Health Education Standards by Topic Area – Reference Companion

This resource is a companion document to a <u>series of one-pagers</u> (y <u>en Español</u>) examining the updated (2023) health education standards by topic area and grade level. This companion document includes <u>reference numbers for each of the standards</u> included for each line of those one pagers. Otherwise the content is the same, presented in a different way.

Consent

- Discuss/Demonstrate how to effectively identify and communicate wants, needs, consent, and personal boundaries in healthy ways and listen to/show respect for the boundaries of others. (K.HRVP.5, 1.HRVP.5, 2.HRVP.2, 3.HRVP.4, 8.HRVP.4)

- Demonstrate communication skills for asserting boundaries around and refusing substance use. (4.SUB.6, 5.SUB.7)
- Describe personal feelings when boundaries, consent, and privacy needs are not respected. (6.HVRP.4)

Sex and Reproduction

 Identify trusted adults (including parents, caregivers, and health care professionals) who can provide valid/reliable health information/services on
