- Comply with any court order, law, or legal process, including in an effort to comply with any legal process which may be served upon LWC and/or its website, or to respond to any government or regulatory request; and
- Protect, maintain, safeguard and/or preserve all the rights, property, or safety of LWC, our customers, or others.

In certain circumstances, we may use our website, newspapers, or other public means to post a notice.
