Dear Governor Parson and Paula Nickelson, Acting Director of the Missouri Department of Health and Senior Services:

The ongoing release of emerging data from experts in the medical field regarding the harmful and often deadly side effects related to COVID-19 shots and boosters is of immediate concern to Missourians as a matter of health and safety. In particular, the impact that these initial shots and boosters have on young adults and children is of particular concern. As the Governor of Missouri and as the Acting Director of Health, this health concern falls under your oversight.

Freedom Principle MO is calling on you and your offices to immediately halt all COVID-19 vaccinations and boosters until a fully independent, scientific investigation of the COVID-19 vaccines and boosters can be conducted to evaluate their efficacy in treating and preventing the transmission of the COVID-19 virus, based on the following evidence:

- Professor Retsef Levi, the renowned MIT professor, and Drug Safety Analytics Specialist is calling for the immediate suspension of COVID mRNA vaccines. On January 30, 2023, Professor Levi stated that the pharmaceutical companies “completely failed to fulfill any of their advertised promise regarding efficacy. And more importantly, they should stop because of the mounting and indisputable evidence that they cause an unprecedented level of harm, including the death of young people and children.”
- In an article published on January 19, 2023, *The Epoch Times* reported that the Center for Disease Control and Prevention (CDC) omitted serious adverse effects like heart inflammation on post-vaccination surveys even though they knew the issues could be linked to the COVID-19 vaccinations. The Informed Consent Action Network (ICAN), a nonprofit that seeks transparency around health information, reported the CDC omitted from its V-Safe system, symptoms like “myocarditis, stroke, death, and a “prescribed medical conditions.”
- During a COVID-19 EU hearing held on October 10, 2022, Janine Small, Pfizer’s president of International Development Markets, testified that the Pfizer vaccine had never been tested on its ability to prevent virus transmission.

With these stunning admissions, it is imperative for you and the Acting Director to take immediate action to help protect Missourians.

Further, thousands of Missourians were unconstitutionally forced to get the one or two-phase shots and subsequent boosters, not by choice, but under the threat of losing their job and not being allowed to attend school. Others were essentially coerced into getting the vaccine, thinking it would prevent the spread of the infection. As a result, many of these individuals have suffered side effects, long-term injuries, and even death as the result of these experimental shots.

As a matter of public safety and constitutional integrity, Freedom Principle MO is asking you to issue an immediate Executive Order prohibiting any employer, including healthcare, or education facilities from requiring the COVID-19 vaccination as a condition of employment, promotion, or attendance until the legislature can address this issue legislatively and as per the following evidence of wrongdoing:

- The U.S. government's Vaccine Adverse Events Reporting System (VAERS) reports 30,000 deaths and over 50,000 permanent disabilities related to the vaccine worldwide (*Research Study: "Serious Adverse Events of Special Interest Following mRNA Vaccination in Randomized Trials," published by the Social Science Research Network*). Of these worldwide statistics, the VAERS reports the following data in the United States regarding adverse effects of the COVID shot as of January 20, 2023:
 - 16,537 Deaths
 - 74,750 Hospitalizations
 - 110,998 Urgent Care Visits
 - 2,423 Reports of Anaphylaxis Reactions
 - 6,051 Reported cases of Bell's Palsy

In addition, the VAERS also reports the side effects that are impacting Missourians and Americans:

- 1,992 Miscarriages
 - 7,410 Heart Attacks
 - 4,820 Cases of Myocarditis/Pericarditis
 - 16,073 Permanently Disabled

- "Pfizer and Moderna mRNA COVID-19 vaccines were associated with an increased risk of serious adverse events of special interest, with an absolute risk increase of 10.1 and 15.1 per 10,000 vaccinated" (*Research Study: "Serious Adverse Events of Special Interest Following mRNA Vaccination in Randomized Trials," published by the Social Science Research Network*). The adverse effects cited in the study include Sudden Adult Death Syndrome (SADD), myocarditis, pulmonary embolism, blood clots, and immune system failure.

- One in 700 children under the age of five who received the Pfizer mRNA COVID vaccine was hospitalized with severe adverse events, and one in every 200 children had symptoms that were currently ongoing and thus of unknown significance (*“Comparative Safety of the BNT162b2 Messenger RNA COVID-19 Vaccine vs Other Approved Vaccines in Children Younger Than 5 Years” published in the Journal of The American Medical Association*).
- In unredacted agreements between Pfizer and the EU, Professor Norman Fenton, Professor of Risk Management at Queen Mary University of London, uncovered there are four contracts between Pfizer/BioNTech and the Republic of Slovenia that “further acknowledges that the long-term effects and efficacy of the Vaccine are not currently known.”
- “Pfizer’s Paxlovid COVID-19 can have harmful interactions with common medications used to treat cardiovascular disease” (*“Drug-Drug Interactions with Nirmatrelvir/Ritonavir (Plaxlovid) and Select Cardiovascular Medications” published by the Journal of the American College of Cardiology*). According to the study, “Co-administration of NMVr with medications commonly used to manage cardiovascular conditions can potentially cause significant drug-drug interactions and may lead to severe adverse effects.”

This emergence of actual scientific data evidence disproves the narrative of “safe and effective” and has uncovered one of the most appalling crimes against humanity. Missourians and Americans have been lied to by the CDC, Pfizer, Dr. Fauci, the Biden Administration, the Federal Drug Administration (FDA), the U.S. Department of Health and Human Services (HHS), and the media. That our government and government agencies worked together with Big Pharma and Big Tech to deceive the public into taking the COVID-19 shot is enough reason to suspend any further implementation of the COVID-19 vaccine distribution. Given the additional medical information and scientific data now emerging regarding the harmful effects of the mRNA vaccine and treatments, Missouri should take the bold action of halting the distribution and promotion of COVID-19 shots.

Furthermore, the Freedom Principle MO is asking for an investigation, by the Missouri Attorney General into consumer fraud and price gauging by Pfizer after it announced a 400% increase in the price of their mRNA COVID shot after the CDC panel recommended adding COVID shots to children and adolescents’ annual immunization schedule. The pharmaceutical drug manufacturers are price gauging consumers as government contracts expire, making the direct cost of COVID shot 400% higher (\$110 to \$130 per dosage).

In the end, medical fraud has been perpetrated on Missouri citizens. Missouri public health officials should not be promoting any COVID shots or boosters until these treatments can be proven to be safe and effective in preventing infection and transmission of the virus by an independent lab. Given this shocking fraud against citizens, we are calling on you, Governor Parson, and Acting Director Nickelson to step up for Missourians.
