Settlement Agreement Between University of California, UPTE-CWA Local 9119, and Teamsters Local 2010 in Resolution of Unit Modification Petitions in PERB Case Nos. SF-UM-856-H and SF-UM-866-H

Teamsters Local 2010, UPTE-CWA Local 9119, and the University of California agree as follows:

- 1. The parties agree that the Community Health Program Representative ("CHPR") classification will cease to be utilized at UCLA Health.
- 2. The parties agree that the employees that are currently in the CHPR classification will be moved into either the CX unit or the HX unit in accordance with Exhibit A to this settlement agreement.
- 3. The University has made its best effort to identify all CHPRs and believes there are no CHPRs other than those identified in Exhibit A; however, the parties acknowledge that there may exist CHPRs not identified in Exhibit A. The parties agree that the University is responsible for classifying jobs, and that the University will classify positions into appropriate titles within appropriate bargaining units. The parties agree that work primarily associated with HX bargaining unit work will be added to HX. The parties agree that work primarily associated with CX bargaining unit work will be added to CX. If the University finds that any CHPRs exist beyond those identified in Exhibit A, it will promptly provide notice to Teamsters and UPTE after it becomes aware.
- 4. The parties agree that Marisol Farias shall be granted preference for any active, vacant career bargaining unit position at the Venice Family Clinic for which Ms. Farias applies and is qualified. Ms. Farias shall retain this preference for one (1) year from the date of her accretion into the CX unit. In the interim, the parties agree that Ms. Farias will be moved into the CX unit.
- 5. Based on the University's mapping in Exhibit A, the parties acknowledge that all of the current CHPRs that are moving into the HX unit are proposed to be classified as Social Work Associates. However, the parties reserve the right to negotiate regarding other classifications within the HX unit after the settlement is executed.
- 6. Based on the University's mapping in Exhibit A, the parties acknowledge that the current CHPRs that are moving into the CX unit are proposed to be classified as Blank Assistant III's with the exception of the limited number of employees classified as Blank Assistant II's and Administrative Officer II's in Exhibit A. However, the parties reserve the right to negotiate regarding other classifications within the CX unit after the settlement is executed.
- 7. The parties agree that CHPRs identified in Exhibit A will be included in the respective bargaining unit upon execution of this settlement agreement or if applicable, retroactive to the execution of this settlement agreement.

- 8. The parties agree that Teamsters and the University will meet to engage in post-accretion bargaining regarding the inclusion of those CHPRs that will be going into the CX unit.
- 9. The parties agree that UPTE and the University will meet to engage in post-accretion bargaining regarding the inclusion of those CHPRs that will be going into the HX unit.
- 10. This Agreement shall not be considered precedential, nor cited as precedential, by any party.
