THE abortion Pill

➤ also known as chemical abortion, medical abortion, RU-486, or "plan c"

➤ regimen of medication taken to kill & expel a developing baby within 13 weeks of last missed period (LMP)

consists of
mifepristone
(Mifeprex) followed
by misoprostol
(Cytotec)

➤ different from emergency contraception aka "Plan B" which prevents an egg from releasing

➤ 53% of abortions are done with the abortion pill. In 2020, the abortion pill killed over 865,000 developing babies.



HOW IT KILLS

1 mifepristone blocks progesterone: causes womb lining to break down

- 2 lining is baby's only oxygen source: baby starves, suffocates, & dies
- 3 misoprostol makes womb contract: dead baby pushed out with lining

4 remains may be whole within sac or decay & be torn apart by contractions

Danger To abortion Seekers

➤ 1 in 5 experience a complication from taking the abortion pill (rate 4x higher than surgical abortion)

► can cause severe hemorrhaging & weakens immune system

► 28 women died from abortion pill between 2000-2022

 repeat abortions are riskier for 12 months after

► 1 in 20 visit ER after taking (50% more than surgical abortion)

➤ sepsis possible if parts of baby get left in womb (requires surgery)

➤ physical pain described as "worst ever felt", "worse than childbirth", "scared I was dying"

➤ remains flushed down drain put biohazard waste in water system

► parents **traumatized** by seeing & discarding baby remains

➤ invented by company derived from maker of Nazi poison gas

EMBRYO By Week

► 5 wks LMP: facial features developing & nipples grown

6 wks LMP: baby's heart is beating (hear it on an ultrasound!)

► 8 wks LMP: develops nerves, starts to wiggle & squirm around

➤ 9 wks LMP: transitions from embryo to fetus

➤ 11 wks LMP: all major organs are in place & full body grows bigger

► 13 wks LMP: baby is peeing in the womb!

DEREGULATION Relaxed Rems* & Raises Risks

If an abortion seeker is not examined by a doctor inperson before taking the abortion pill, preventable complications may become **life-threatening**.

undetected ectopic pregnancyfallopian tube rupture

 miscalculated LMP
too far along to deliver safely alone, or failed abortion

➤ Rh-factor incompatibility = immune response will harm future babies

no identity verified in-person
= pills prescribed to phony patient
who is (or aids) an abuser

no in-person screening
trafficker can force
a victim into procuring pills

 expanded access
increases cultural pressure to abort when in crisis
