Yes, it could have ups and downs and one year is 1:9, so the provider if they needed to withdraw funds might wait if it was worth less, or they could wait for a banger year and withdraw funds at a higher level (say 1:1.1) which could be a sizable profit. It's a crypto currency that is transferable with anyone that "creates" a wallet. Then distribute a specific amount of currency to individuals. This can then be traded among who ever. Technically it can go between two parents that trade off shifts per week after school. However the only people that can "cash it in" are those that are registered as a child care facility. So family 1 that did a bit more "baby-sitting" gets to have an extra couple days of gymnastics. A high-school babysitter who watches kids could accept it at 1: 2 ratio to pay for instruction time at the recreation center for "rock-climbing" lessons or whatever. But in turn, by creating a "buck" that has tradeable value you create a system where people want them. Also everything is track. Not a single cent would ever go missing. The state in turn gets direct and almost instantaneous knowledge of who is being a FFN provider."	the Carebucks could only be cashed in with licensed providers. The technology would also allow Carebucks to go up and down in value like publicly traded currency, so how much providers received would depend on the value of the Carebucks on the day they cash them in. Finally, the technology would automatically keep a transaction history of every single Carebuck.
