

## **Standard Artwork Exhibition Agreement**

The Textile Arts Center of Madison ("TAC") 2436 Pennsylvania Avenue Madison, WI 53704

*I hereby enter into the following Agreement:* 

- 1. Exhibition. TAC accepts for exhibition, those Artworks listed on the attached Inventory Sheet which is part of this Agreement. All Inventory Sheets shall be signed by the Artist and TAC. TAC shall not permit the Artworks to be used for any other purposes without the written consent of the Artist.
- 2. *Warranty*. The Artist hereby warrants that he/she/they created the Artworks and possesses unencumbered title to the Artworks, and that their descriptions are true and accurate.
- 3. Duration of Exhibition. The Artist and TAC agree on the exhibition dates of:

Start Date: <u>September 8, 2024</u> End Date: <u>October 21, 2024</u>

and that the Artist does not intend to request the return of the Artworks before the end of this term. The term may be extended if both parties agree and this Agreement is modified as per item 9 below.

- 4. *Transportation Responsibilities*. Packing, transportation of, and handling expenses and risk of loss or damage incurred in the delivery of Artworks from the Artist to TAC or to a TAC representative, and in their return to the Artist, shall be the responsibility of the Artist.
- 5. Responsibility for Loss or Damage. TAC shall be responsible for the safekeeping of all Artworks while they are in its custody, including at the time when Artworks are transferred to a TAC representative or delivered to TAC. TAC holds insurance which covers loss or damage to the Artworks while they are in its custody. The Artist is responsible for the Artworks at all other times and it is recommended that the Artist also insure their exhibited Artworks.
- 6. Sales. The Artist will provide a price list to TAC and TAC will make it known via signage which artworks are available for sale. TAC will handle the sale of the artwork and will retain a commission of 30%.
- 7. Removal from TAC. TAC shall not lend out or remove from the premises any of the Artworks without first obtaining written permission from the Artist.
- 8. Reproduction. The Artist reserves all rights to the reproduction of the Artworks. TAC may arrange to have the Artworks photographed to publicize and promote the Artworks, the exhibition, and/or TAC. In every instance of such use where the Artwork is the sole or major focus of a photograph, the Artist shall be acknowledged as the creator and copyright owner of the Artwork.
- 9. *Termination of Agreement*. Notwithstanding any other provision of this Agreement, this Agreement may be terminated at any time by either TAC or the Artist, by means of written notification of termination from either party to the other.

- 10. Procedures for Modification. Amendments to this Agreement must be signed by both the Artist and TAC and attached to this Agreement. Both parties must initial any deletions made on this form and any additional provisions written into it.
- 11. *Miscellany*. This Agreement represents the entire agreement between the Artist and TAC. If any part of this Agreement is held to be illegal, void, or unenforceable for any reason, such holding shall not affect the validity and enforceability of any other part.
- 12. Choice of Law. This Agreement shall be governed by the laws of the State of Wisconsin.
