- Conduct research and collect data to document the existing flow and recovery of poly coated paper products.
- Expand end-market acceptance of poly-coated paper products and provide mill support to drive widespread adoption.
- Establish universal design guidance, such as minimum fiber thresholds and acceptable coatings, so end markets know what to expect in poly coated paper products.
- Communicate the benefits of poly coated paper as both a high-quality and highly recyclable packaging option to communities, haulers, processors, and manufacturers.

PCPA Phase 1 Review (2023-2025)

Our initial goal at the PCPA was to build a strong industry coalition that would document where poly coated paper is being recycled, how effectively it is being collected and sorted and processed, and whether and how it is reaching end markets. **We've made great progress:**



To date, PCPA has worked to close the data gap of poly coated paper recycling through multiple methods, including subject matter expert

interviews, quantitative surveys, market research, access searching, and empirical field work. Field work to date has included **bale audits, RFID testing, and sortation testing.**



End Markets

PCPA is evaluating how end markets interact with poly coated paper by **conducting end market interviews and repulpability trials.**

As of April 2025, PCPA has interviewed nine paper mills across the U.S., spanning white and brown fiber users, and is conducting a repulpability test of representative package types at one of our member paper mills, Sonoco.



Universal Design Guidance

PCPA is developing a Design for Recyclability Guideline with the goal that it will provide design insights for packaging converters and brands.

This current iteration of the **Design Guide will provide guidance on MRF sortability** and will integrate some of the findings from PCPA RFID testing. The primary focus of the Design Guide is end market compatibility.



Common Messaging

This year, PCPA established a cohesive brand identity, ensuring clear and consistent communication of our mission. In this effort,

we've launched a dynamic website, logo, engaging fact sheets, and created compelling conference abstracts to expand our reach. Looking ahead, we're committed to sharing key insights from bale audits and repulpability studies through our website, conferences, webinars, and other channels, while continuing to grow our membership and strengthen industry connections.
