- **GOLF CARTS NOT ALLOWED ON SHOW GROUNDS**
- Dumping stations and shower facilities are located near camping areas
- Pets are allowed in the camping areas only and must remain leashed at all times
- 3 night minimum, Saturday night stay required.
- No Campfires Allowed per NY State Fire Marshall
- All spaces are 20 feet wide by 40 feet deep

# ***Syracuse Nationals***

## **2024 ON-SITE CAMPING RULES AND REGULATIONS**

Please read the entire attachment. The following information explains the many rules and regulations enforced by the NYS Health Department and will enhance your experience at the Syracuse Nationals.

**1.** Pick up your camping credentials and register your camping party when entering the NYS Fairgrounds. Follow camping signs to the registration office located inside Gate 7.

**2.** All persons entering the camping area must have a 3-day wristband. These are available for purchase on this application, or at Gate 7 at the event, for \$55 per person.

**3.** Each campsite will only be allowed two motorized vehicles in the campgrounds. Examples are 1 tow vehicle and 1 show car or one tow vehicle and one daily driver. Stickers must be affixed to the outside of every vehicle's windshield. Additional camping parking stickers can be purchased for \$25.00 per vehicle (limit 2 additional per camp site); this can be done during the registration process.

**4.** Hook up sites (water/electric) are limited and booked on a first come, first served basis. Camping reservations made after all hook up sites are sold out will be automatically be reserved for dry camping (no hook ups).

**5.** Ticketed camping visitors will park in spectator parking lots. Only vehicles with camping credentials are allowed in campgrounds.

### **6. GOLF CARTS**

**GOLF CARTS ARE NOT ALLOWED ON SHOW GROUNDS  
GOLF CARTS ARE ALLOWED IN CAMPGROUNDS ONLY**

Any golf carts or other unauthorized vehicles found on show grounds will be immediately evicted without refund.

Only approved single occupant handicapped mobility devices are allowed on the show grounds.

**ONLY LICENSED DRIVERS MAY OPERATE GOLF CARTS  
OR OTHER APPROVED MOBILITY DEVICES**

**7.** Due to New York State Health Department regulations tent camping is NOT allowed.

**8.** RV's, campers, tow vehicles, and street cars are not allowed on the show grounds for any reason.

**9.** Portable toilets, showers and handwash sinks will be provided and staged in convenient locations to meet NY State Health Department regulations.

### **10. CAMPFIRES ARE NOT ALLOWED PER NEW YORK STATE FIRE MARSHALL.**

**11.** All sites are 20' wide by 40' deep and subject to current NYS Health Department guidelines. Be sure your slide-outs and awnings are inside your assigned area or adhere to current NYS Health Department mandatory 10-foot clearance guidelines. In order to be compliant to NYS Health Department rules, and for your safety, follow direction of the staff member placing your camper.

**12.** Camping units in any "dry camping" areas will be placed such that there is a separation distance of not less than 10 feet between camping units, including any add-on structures or appurtenances attached to the camping unit.

**13.** No dumping of grey/black water is ever allowed. This zero-tolerance policy which is enforced by the New York State Health Department, which is on site, all fines will be the responsibility of the registrant. Violations can result in eviction from the campgrounds without refund. Sewer flush valves are not allowed.

**14.** Camping patrons will be notified of all dumping stations and scavenger service upon arrival.

**15.** Pets are allowed in campgrounds only. Pets are not allowed on the show grounds. Pets in the campgrounds must always be on a leash. Pets cannot be left unattended. You must clean up after your pet. Violation of any of these rules will result in ejection from the event without refund.

**16.** Vendor displays/demo areas are ONLY allowed in the event showgrounds. Displays are NOT allowed in the camp ground areas.

**17.** All roads must always remain clear for emergency access.

**18.** If you want to park together you must arrive together. Staff will do their best to accomodate your request.

**19.** Campers are NOT ALLOWED to move after camping staff assigns you a camping site. Moving to different site without permission from camping staff will result in immediate removal from event with no refunds.
