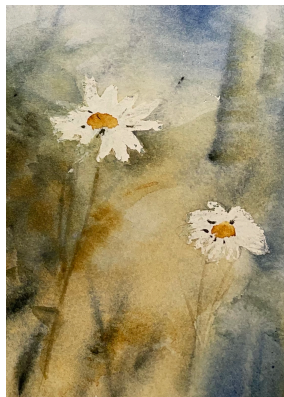
“Add on” September 23-27 for (4) additional nights in Cavtat, Croatia (includes breakfast)

PARTICIPATION IN AN ART ON THE FLY TRAVEL PROGRAM

WAIVER AND RELEASE

The following individual, _____, ("the Participant") will participate in an international travel program ("Program") organized and offered by Art on the Fly, a Wisconsin limited liability company. The undersigned acknowledges and agrees that they have the authority to sign this Waiver and Release on behalf of themselves or the Participant, who is the undersigned's child or ward. If Participant is eighteen (18) years of age or older, or if Participant attains the age of eighteen (18) years of age prior to the Program's departure, they must also agree to the terms and conditions of this Waiver and Release by also signing this form below.

For purposes of this Waiver and Release, Art on the Fly includes all owners, officers, directors, employees, agents, representatives, assigns, successors, insurers, subsidiaries, and affiliates of Art on the Fly (collectively, the "Released Parties"). In consideration for the Participant being permitted to participate in the Program, and any and all events or activities that are or might be associated with the Program, the undersigned agrees on behalf of the Participant and each of their respective family members, heirs and assigns to release, waive, discharge and hold harmless the Released Parties from and against any and all rights, claims, demands, causes of action, obligations, suits, proceedings, liens, damages, injuries, losses, liabilities, costs or expenses of any kind that could be brought by the undersigned or the Participant or a third party acting on their behalf arising from or relating to the Program.

The undersigned assumes full responsibility for any such losses, injuries, damages, costs, or expenses which may occur as a result of the Program and agrees that the Released Parties shall not be liable for any loss or theft of personal property. The undersigned specifically agrees that the Released Parties shall not be liable or responsible for any such losses, injuries, damages, costs, expenses or theft, even in the event of negligence by the Released Parties. However, this Waiver and Release does not apply to intentional conduct by the Released Parties. If the Participant or legal guardian is uncomfortable with any of the terms of this agreement, they should contact Art on the Fly at artonthefly2018@gmail.com to discuss prior to signing this waiver.

PHOTOGRAPH RELEASE

The undersigned hereby grants Art on the Fly the irrevocable right and permission to photograph and/or record the Participant in connection with the Program and other Art on the Fly activities and to use the photographs and/or recordings for all purposes, including advertising and promotional purposes, in any manner and all media now or hereafter known, in perpetuity throughout the world, without restriction as to alteration and without compensation.

COVID-19 SAFETY ACKNOWLEDGMENT – LIABILITY WAIVER AND RELEASE OF CLAIMS

COVID-19 SAFETY INFORMATION:

While participating in events held or sponsored by Art on the Fly, consistent with CDC guidelines, Participants are encouraged to practice hand hygiene and "social distancing" to reduce the risks of exposure to COVID-19. Because COVID-19 is extremely contagious and is spread mainly from person-to-person contact, Art on the Fly cannot guarantee that its participants, volunteers, partners, or others in attendance will not become infected with COVID-19. In light of the ongoing spread of COVID-19, individuals who fall within any of the categories below should not engage in Art on the Fly events. Prior to commencing travel with the Program, Participant must not fall into any of the following categories:

1. Individuals who currently, or within the past fourteen (14) days, have experienced any symptoms associated with COVID-19, which include fever, cough, and shortness of breath among others;
2. Individuals who have traveled at any point in the past fourteen (14) days either internationally or to a community in the U.S. that has experienced or is experiencing sustained community spread of COVID-19; or
3. Individuals who believe that they may have been exposed to a case of COVID-19 or have been diagnosed with COVID-19 and are not yet cleared as non-contagious by state or local public health authorities or the health care team responsible for their treatment.

DUTY TO SELF-MONITOR:

Participants agree to self-monitor for signs and symptoms of COVID-19 (symptoms typically include, but are not limited to, fever, cough, and shortness of breath) and, contact Art on the Fly at artonthefly2018@gmail.com if they experience symptoms of COVID-19 within 14 days before or after participating in an Art on the Fly event.

MEDICAL ACKNOWLEDGEMENT AND RELEASE

The undersigned acknowledges the health risks associated with the Program, including those related to international travel, such as local health conditions, among others. The undersigned agrees that if the Participant experiences any of these or any other symptoms during the Program, they will discontinue participation immediately and seek appropriate medical attention. The undersigned agrees that if Participant experiences and/or displays any symptoms related to COVID-19 (fever, cough, runny nose and shortness of breath among others), the Participant will submit to a COVID-19 test. THE UNDERSIGNED DOES HEREBY RELEASE AND FOREVER DISCHARGE THE RELEASED PARTIES FROM ANY CLAIM WHATSOEVER WHICH ARISES OR MAY HEREAFTER ARISE ON ACCOUNT OF ANY FIRST AID, TREATMENT, OR SERVICE RENDERED IN CONNECTION WITH PARTICIPANT'S PARTICIPATION IN THE PROGRAM.

EXPRESS ASSUMPTION OF RISK

This Waiver and Release is applicable to the Participant's participation in the Program and all events and activities relating to the Program. The undersigned acknowledges that participation in the Program may involve significant known and unknown risks of bodily injury, property damage, and other dangers associated with international travel and educational programs. Participation includes possible exposure to and illness from infectious diseases including but not limited to COVID-19. While particular rules and personal discipline may reduce this risk, the risk of serious illness and death does exist. The undersigned and Participant knowingly and freely assume all such risks related to illness and infectious diseases, such as COVID-19, even if arising from the negligence of the Released Parties. The undersigned and Participant understand and agree that the Participant's participation in the Program and its related events and activities is completely voluntary, and the undersigned and Participant assume all risk of injury, illness, damage or loss that might result from the Participant's participation in the Program, even if the risks arise out of the negligence of Art on the Fly.

ACKNOWLEDGMENT OF WAIVER AND RELEASE

The undersigned acknowledges that by signing below, the Participant is giving up substantial legal rights that they may otherwise have and that they may be incurring legal liabilities they would not otherwise have. The undersigned states that they have had sufficient time to review this Waiver and Release with competent legal

counsel of their choice. The undersigned further states that they have carefully read the foregoing Waiver and Release, know the contents thereof, and have signed this Waiver and Release at their own free act. The undersigned understands that their execution of this document or a substitute document approved in writing by the manager of Art on the Fly, who is currently Rita Carpenter (e-mail: artonthefly2018@gmail.com) or her successor, on behalf of Art on the Fly is required for the Participant's participation in the Program and all events or activities relating thereto. The undersigned understands that they have had the opportunity to speak to Art on the Fly's agents if the undersigned has any questions regarding their rights under this document or to negotiate the terms of this document and agree upon an alternative to this document acceptable to the undersigned and Art on the Fly and that they have the authority to approve and execute any alternative to this document. No such alternative document is valid unless approved and signed by Rita Carpenter and the undersigned. By executing this document, the undersigned warrants that the Participant is waiving any right they may have to bring a legal action to assert a claim against Art on the Fly for negligence.

JURISDICTION AND VENUE

This contract shall be construed in accordance with the laws of the state of Wisconsin and the parties hereto agree that venue shall be in Rock County, Wisconsin.

SEVERABILITY

The undersigned hereby agrees that in the event any term or any part of any term of this Waiver and Release is determined to be void or unenforceable, such term or part of a term shall be considered separate and severable from this Waiver and Release and the remaining terms shall continue in full force and effect.
