NOTE: On February 9, 2023 district meeting, Brian Ference, Jeff French, Michelle Rugloski, and Bob Gomez were elected to be on the committee. Bylaws dictate a maximum of four plus the chair, which is appointed by the LD3 Chairman.







Chairman Gomez assigned the duty to the elected committee to vote for their chair, which was Jeff French. Michelle Rugloski and Bob Gomez resigned as they were elected to be on the LD3 board. With Jeff French as chair, that leaves three open positions and the LD3 Chairman still has the option to appoint one of the members. Since Jeff French was elected into the committee, then Chairman Gomez chose Tom Tunget. That leaves the other 2 candidates, Stuart Scurti and Amanda Carlson to be elected by the body. The body elected Stuart Scurti and Amanda Carlson by acclamation.

# Chairman's Report: Bob Gomez

Reported on actions by board meetings:

Policies and Procedures were moved back to August 15, 2022 and revised to allow zoom board meetings to be legitimate.

Policies and procedures were revised to set the limitation for resolutions to be at 500 words instead of 250 words.

Budget was approved.

- Announced that all board meetings are recorded, and that the recordings can be made available to anyone who requests for it.
- Made comments that free speech is important and that tribunals will not happen with this board. There will be no complaint system established for any PC to complain about another.
- Czarny lawsuit hearing on May 30<sup>th</sup>. Regardless of outcome, we need to focus on what we are going to do to save our state and nation. That is why we are here.
- Apologized for slow response from board on emails. Since Czarny has not provided anything to us, including contact information, minutes, etc., we have had to spend a lot of time creating everything.
- Sheets are in the back to sign up for committees. We need your help in a lot of areas.
- Didn't realize how much of a swamp that exists in both parties. We spend a lot of effort looking for bad apples on our side. How about devoting some effort to finding bad apples on the other side? Spend at least one day to find bad apples on the Democrat side and four days on our side. The democrats have already begun preparation for the next election. Find evil ones on their side.
