Approval of July 27, 2023, Meeting Minutes

Unfinished Business:

Proposed total rewrite of Bylaws that was presented in the July District Meeting was acted upon as follows:

Motioned for approval: Tom Tunget; Seconded: Misty Portwood; Debate: None; There were 130 ayes; 2 nays. The percent of ayes was 98, which is far higher than the 2/3 vote needed to pass. The motion passed.

- Board meeting report:

 - Voted to help support community events.

- Captains Meeting: First one took place this last week.
- Basil Meeting visited Freedom Works in DC. Instead of being a speaker to report on his visit, we are recommending that he put together a Zoom meeting for anyone who wishes to attend.
- Lawsuit and court hearing on 9-28-23:
 - Have no issues with PCs attending either meeting. Unfortunately, Ms. Czarny chooses to have her meetings coinciding with ours.
 - Announced that some of us will be testifying in court.
 - Ms. Czarny's emails now will be responded to as it is just propaganda. Basically it is political warfare.
 - $\circ~$ Despite the result of the lawsuit, we will continue on to do our work to save our state and country.
- Czarny Tribunals:
 - Every member of Board has received their notice and chose not to attend her meeting.
 - We are now censured from attending any of her events.
