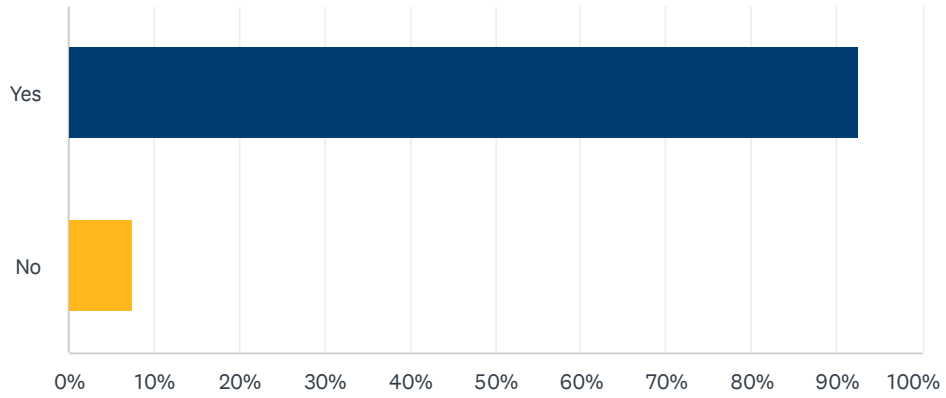

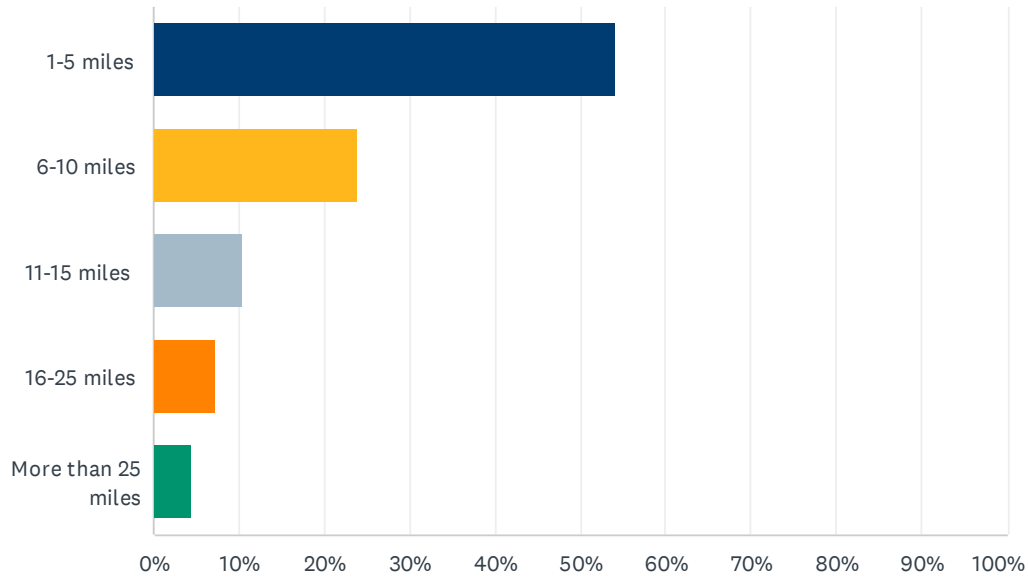

How close do you live to the World Golf Village?

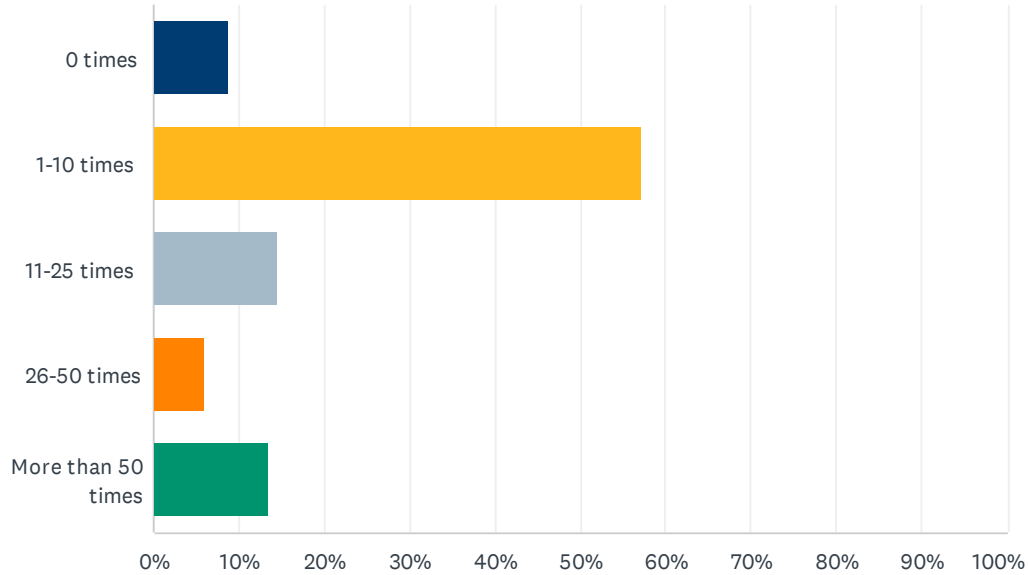

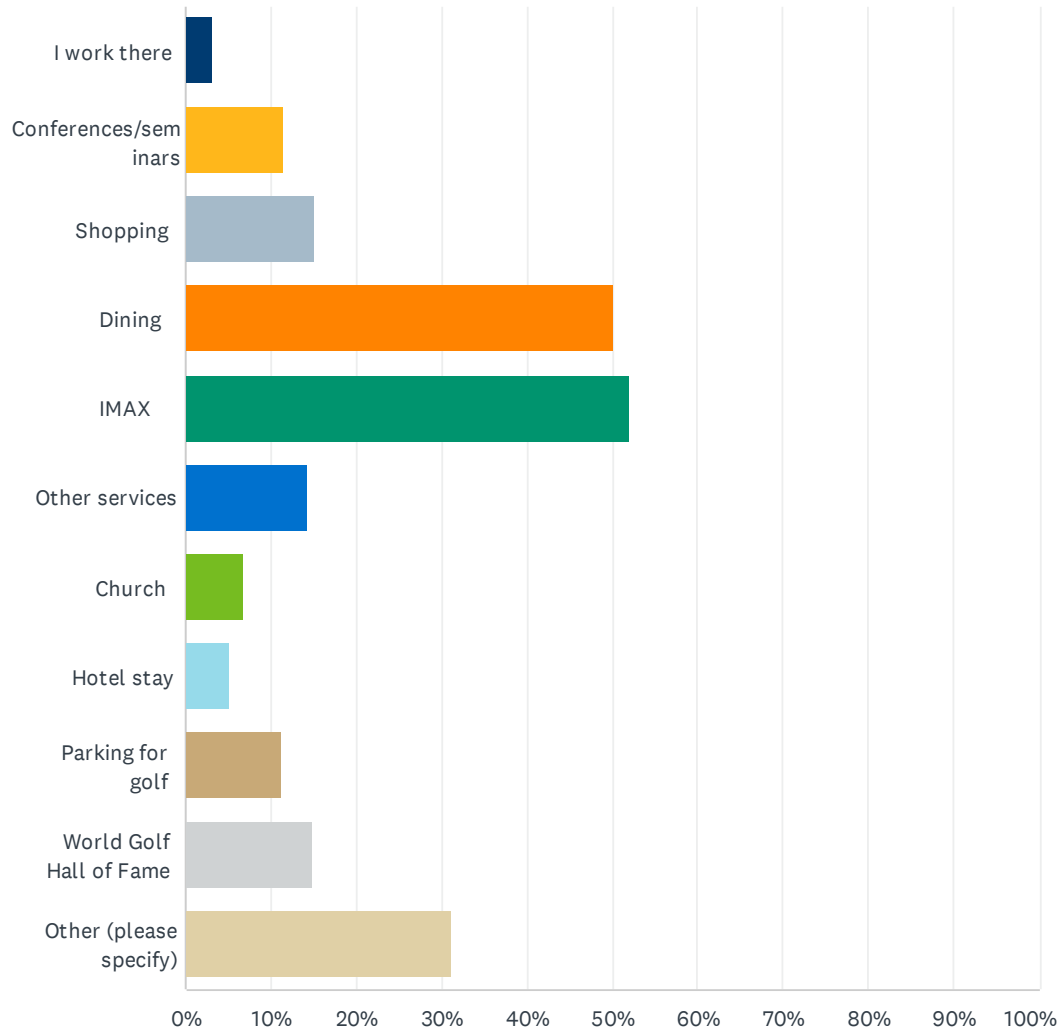

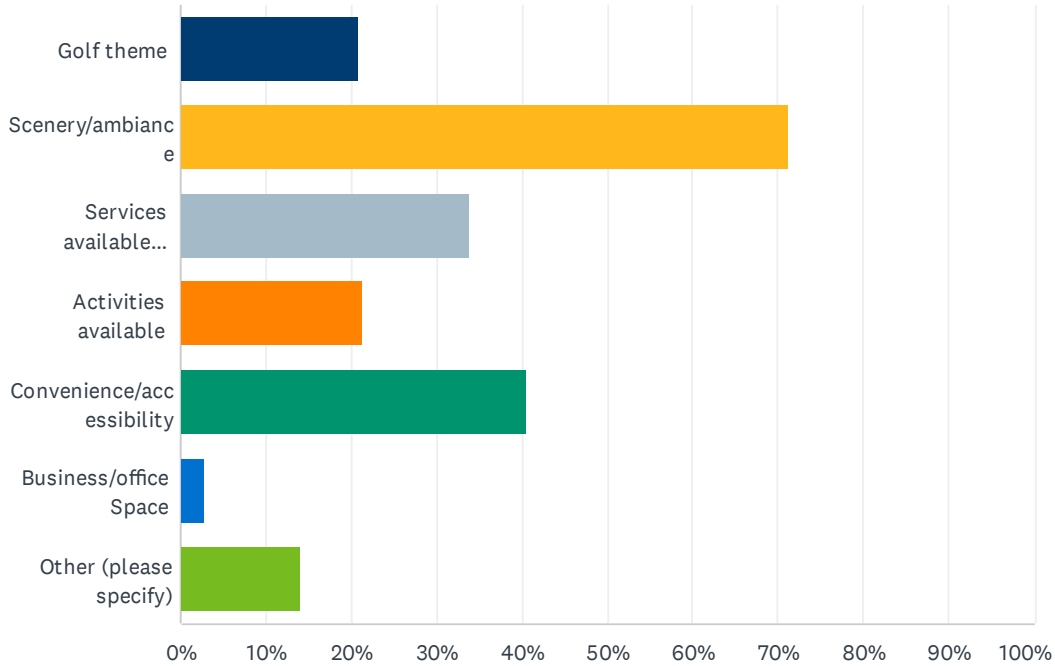
What were the major reason(s) for your visit(s) (please check all that apply)

What did you particularly like about your experience there? (please check all that apply)

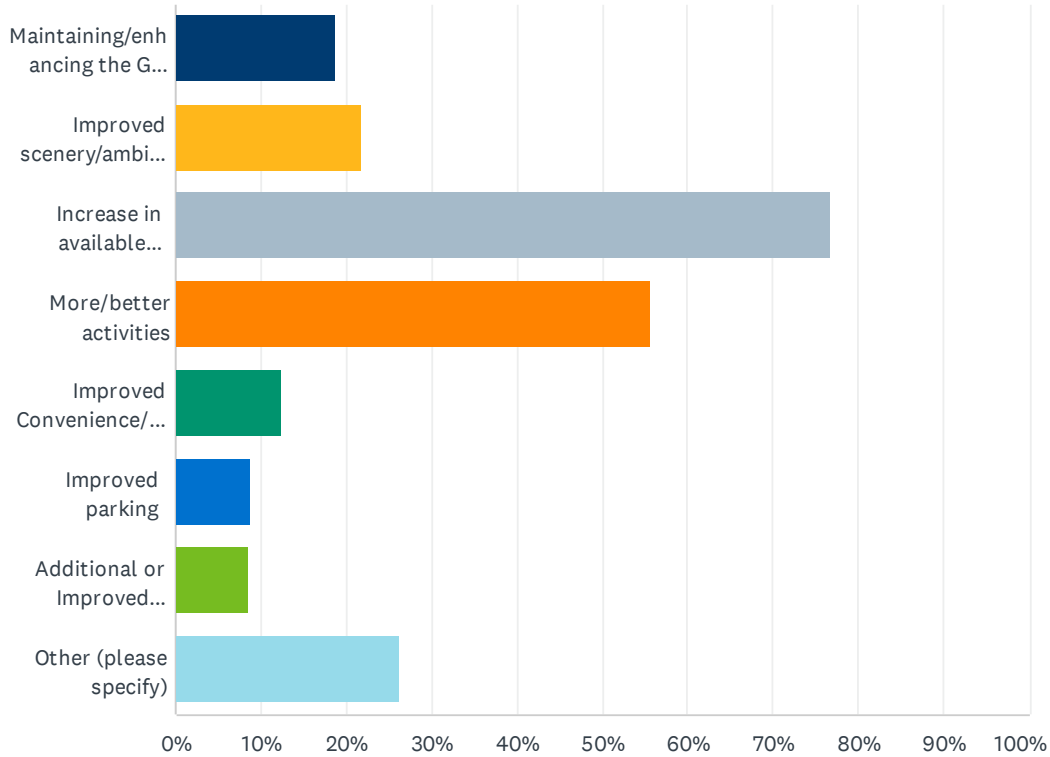

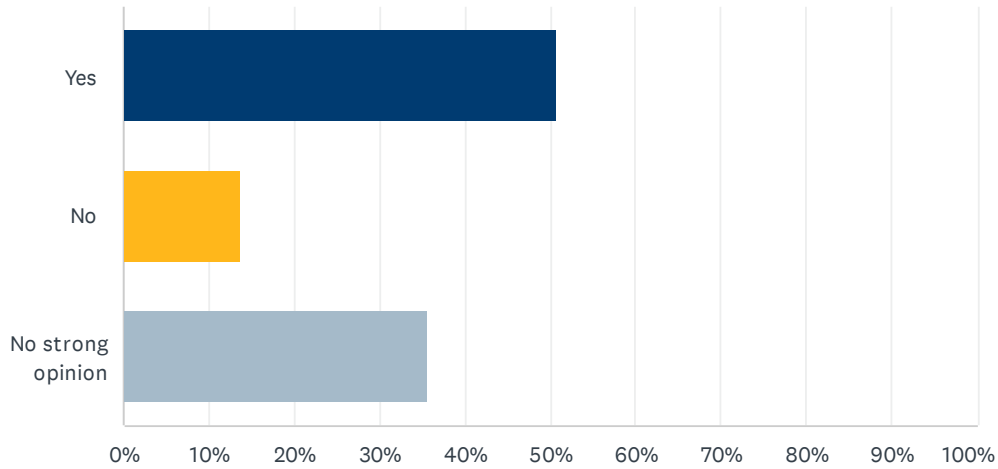

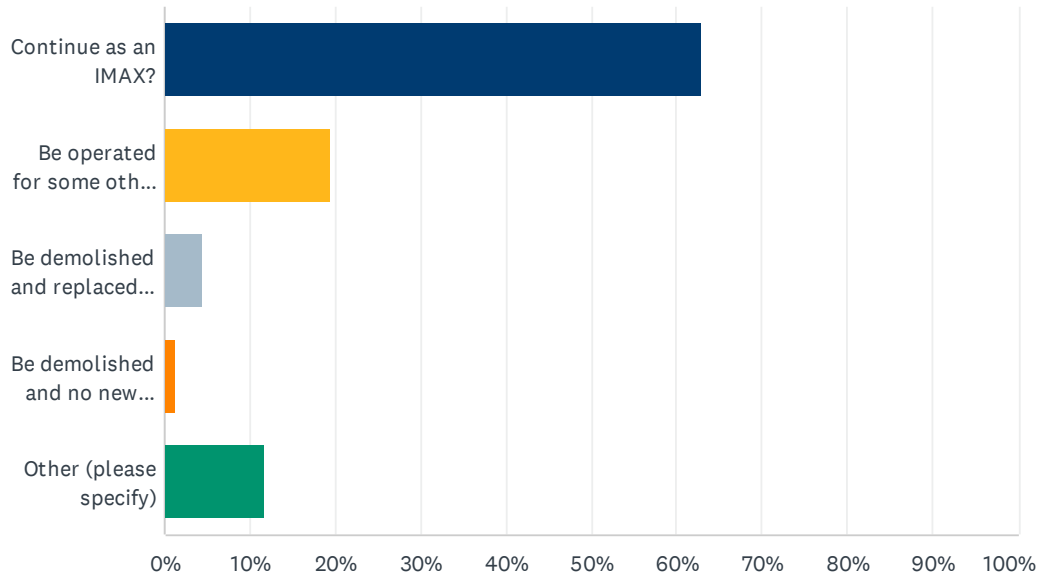

Considering the IMAX building at 1 World Golf Pl., would you prefer that the building

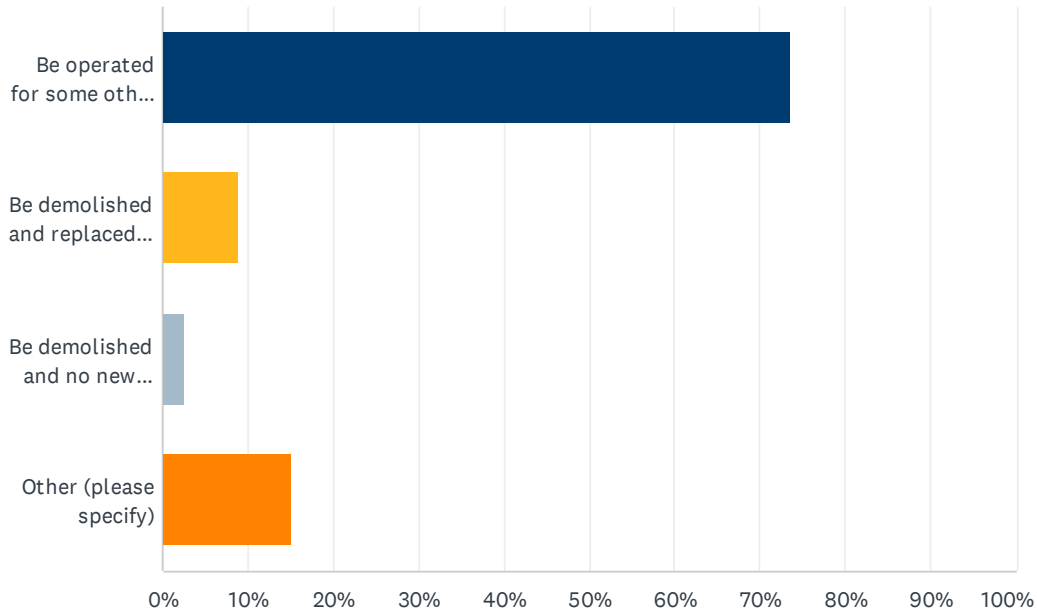

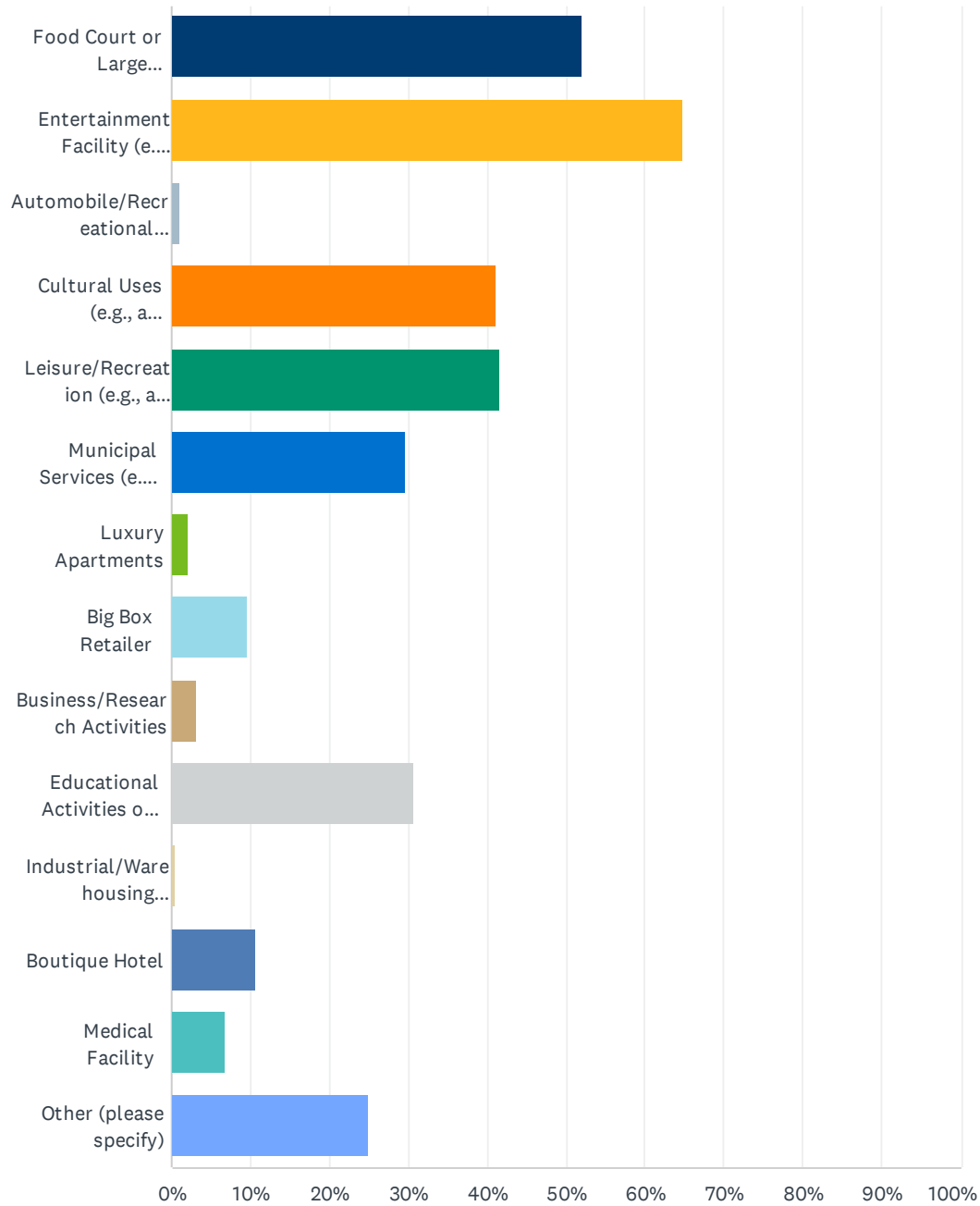

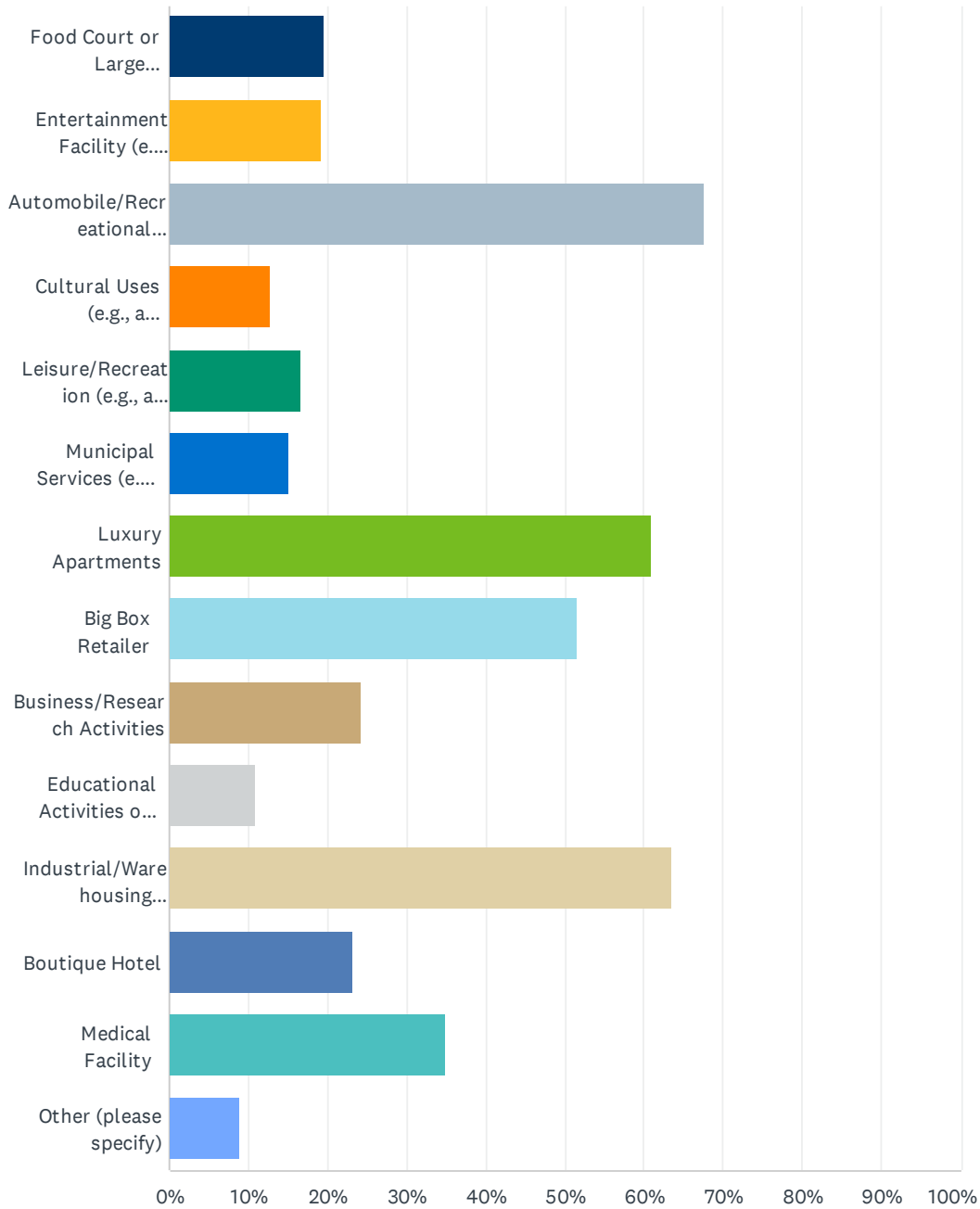
What types of uses for the Hall of Fame building at 1 World Golf Pl. would you like to visit/attend? (please check all that apply)

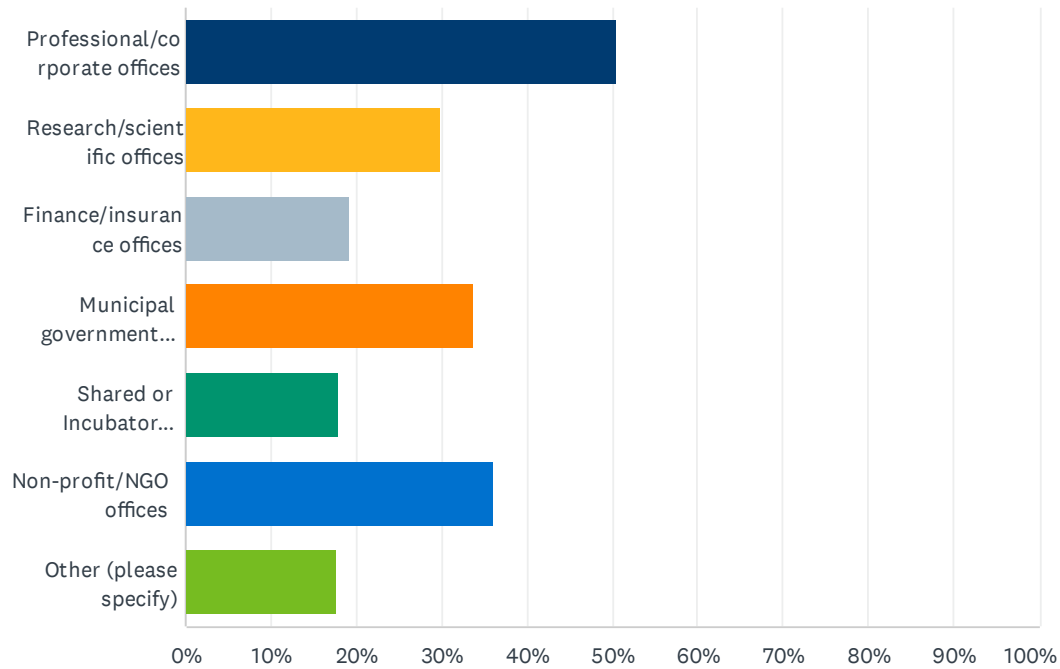
What types of uses for the Hall of Fame building at 1 World Golf Pl. would you be particularly unhappy with? (please check all that apply)

What types of office activities would you like to see at 21 World Golf Pl., after PGA Tour Productions vacates the building? (please check all that apply)

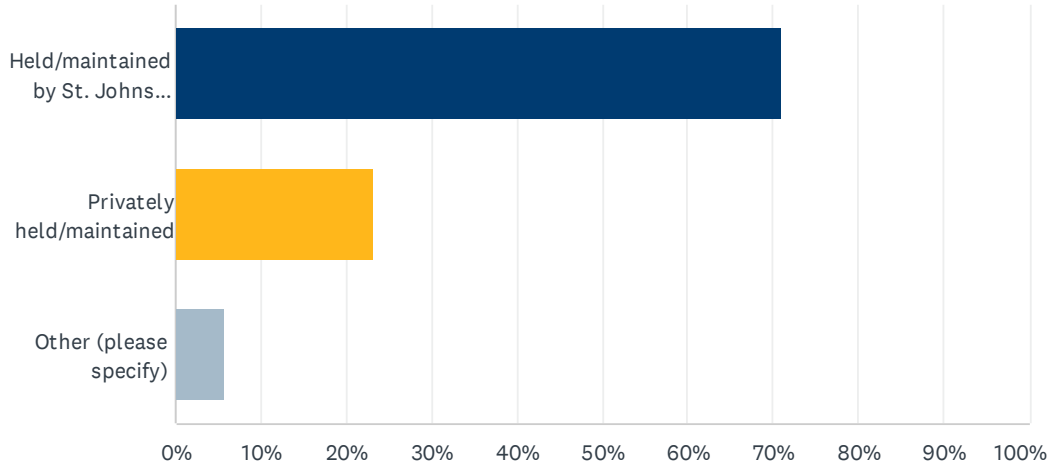
