The <u>Center for Transformative Placemaking</u> is the "hyperlocal" policy solutions hub within Brookings Metro, focused on producing actionable research to reduce spatial inequities both *within* and *across* cities and regions. Transformative placemaking aims to grow more communities of opportunity in which all residents—regardless of zip code, race, or income have equitable access to employment, housing, green space, and affordable transportation.

In this presentation, Brookings Metro Fellow, <u>Tracy Hadden Loh</u>, will present the Center's overall theory of change for building prosperous and equitable regions, starting with <u>hyperlocal activity centers</u>. She will introduce two key tools from which to implement transformative placemaking – one focused on <u>inclusive downtown recovery</u> and the other on <u>cultivating inclusive economic development in historically underinvested, majority-minority neighborhood districts</u>.

#### 1:00 PM Inclusive Growth in St. Louis: From the core to the suburbs

Join us as we tour the region and visit a few of the local organizations leading the way to inclusive growth in the region. This tour will take us from Downtown St. Louis to the <u>Cortex</u> Innovation District through beautiful <u>Forest Park</u> over to <u>Delmar DivINe</u> for a guided tour of the mixed-use development for social innovators that provides office space, shared services and other resources for nonprofits, foundations and community support organizations. Delmar DivINe's mission is to provide a collaborative, innovative space that transforms the community. From Delmar DivINe the tour will take us to Ferguson Missouri, a suburban community approximately 12 miles from Downtown St. Louis to visit <u>Refuge & Restoration</u> <u>Marketplace</u>. A local nonprofit founded in 1999 with a focus on cultivating innovation and brilliance to produce socioeconomic change agents for the future. The tour will end at the <u>Ferguson Community Empowerment Center</u>.

3:30 PM Inclusive Growth in St. Louis: Reflections on 10 Years Since the Killing of Michael Brown Jason Hall, CEO, Greater St. Louis, Inc. Gabe Gore, Circuit Attorney, City of St. Louis Michael McMillan, President & Chief Executive Officer, Urban League of Metropolitan St. Louis Lakesha Mathis, Vice President of Strategy, Greater St. Louis Inc. (*Moderator*) This summer marks the tenth anniversary of the killing of Michael Brown, and unarmed 18year-old Black man, by a white police officer, Darren Wilson, in Ferguson, a suburban community approximately twelve miles from Downtown St. Louis. Brown's death ignited protests, international media coverage, and calls for change to the social and economic conditions that impede progress, equity, and safety in the St. Louis metro. To that end, Missouri Gov. Jay Nixon appointed sixteen members to an independent group, known as the Ferguson Commission, to examine those conditions, engage with citizens and experts, and issue an "unflinching" report containing specific, practical policy recommendations for making the metro area a strong, fairer place for everyone to live. Published in 2015, the Ferguson Commission report directly informed the development of the STL 2030 Jobs Plan, the creation of Greater St. Louis, Inc., and GSL's early policy agenda. Moderated by GSL Vice President Lakesha Mathis, this panel discussion will reflect on the impact of Brown's killing – and the public response to it. Leaders will discuss ongoing efforts to drive inclusive economic growth in St. Louis. The discussion will take place at the Ferguson Community Empowerment Center, operated by the Urban League of Metropolitan St. Louis. The center is found on the site of a gas station that was destroyed in a protest the night after Brown was killed.
