The email was attacked by 33 former and current Republican election officials in an email of their own, which was picked up by the usual Establishment and Liberal media. It was signed by Zuckerbuck enthusiast Pam Anderson, former CO Secretary of State RINO Wayne Williams, and Aurora Mayor Mike Coffman to name a few. They parroted the Dem claim that Peters did not uncover any election fraud. But that's fake news.
