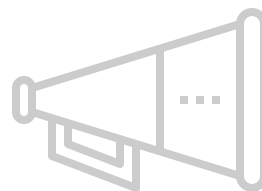


DOBBS V. JACKSON WOMEN'S HEALTH ORGANIZATION **AMICUS BRIEF**

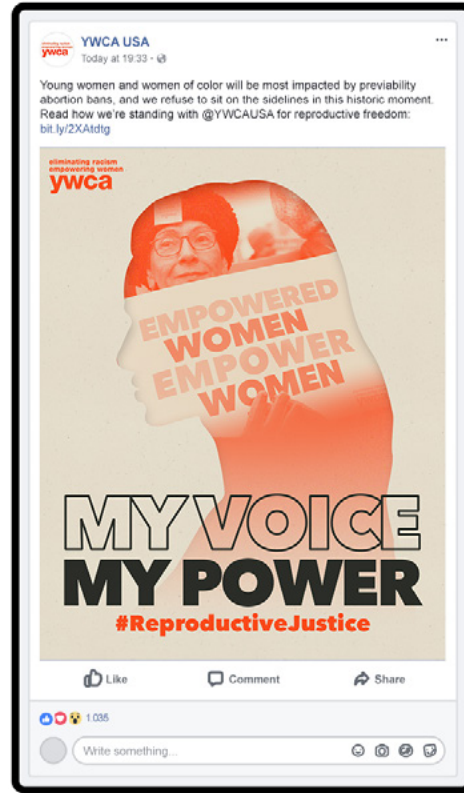
