01 Introduction



1.1 What is Imagine MOPC?

In September 2023, the Municipality of Pictou County (MOPC) launched "Imagine MOPC", a project to develop a municipality-wide Municipal Planning Strategy (MPS) and Land Use Bylaw (LUB) for the Municipality of Pictou County.

Currently, there is no land use planning in MOPC with the exception of the Wind Energy Bylaw and the Subdivision Bylaw. In 2018, the Provincial Government passed new legislation that requires every municipality to adopt land use rules that meet newly established minimum planning standards. The Imagine MOPC project will bring MOPC into compliance with this provincial mandate.

The final MPS and LUB will serve as valuable tools to address land use, infrastructure, environmental sustainability, community needs, and economic growth. These documents will provide long-term vision and direction for the development and growth of the Municipality of Pictou County.

The day-to-day activities of Imagine MOPC are being carried out by UPLAND Planning + Design in collaboration with municipal staff and overseen by a steering committee consisting of Council and the Planning Advisory Committee.

1.2 What is a Municipal Planning Strategy (MPS)?

A Municipal Planning Strategy (MPS) is the primary planning document for the Municipality. It establishes the vision, goals, and policies for growth and development. In other words, it is the road map that helps to guide decision making relating to what we build, where, and at what intensity.

An MPS looks at many different aspects of life in the community including (but not limited to) housing, economic development, agriculture, drinking water, and infrastructure. It also looks at important environmental considerations in our community, like the effects of climate change, coastal erosion and flooding, and the impacts that these have on development.

The Land Use Bylaw (LUB) is the companion document to the MPS, and puts the vision, goals, and policies into action through specific regulations that have to do with development activities. The LUB sets out things like the land use zones (zoning), permitted uses for these zones, standards for development, performance standards, developments to be considered by development agreement, and developments to be considered by the site plan approval process, among other things.



1.3 What is Planning and Why Does it Matter?

Planning is the process by which communities can control change and development in their physical environment. Planning seeks to balance the needs of people, the economy, and the environment by determining where, at what intensity, and in what form certain land uses should take place. It plays a big role in keeping populations safe and healthy and allocates growth through proactive (or deliberate) transportation and infrastructure planning, making it easier and more efficient for people to get around.

Planning matters because...



It **helps us prepare for change** such as environmental change, like sea level rise, or social change, like an aging population.



It **supports our community's character and culture** by promoting good urban design, a quality public realm, and by keeping development consistent and complementary.



It **protects special and sensitive environments** by preventing or limiting development in these areas.



It **helps to protect people** from developing in areas where the natural environment presents a high risk.



It **helps to maintain a healthy, sustainable economy** by ensuring there is a good balance and proximity between places of work and places to live.



1.4 How Will this Report Be Used?

Imagine MOPC began with an extensive public engagement period, which generated a large amount of feedback including areas of agreement, points of contention, specific directions, and priorities. This report summarizes and explores that feedback, grouped into themes. Some of this feedback will be used to inform policy decisions in the draft MPS and LUB, some will be passed on to the Municipality for consideration through other parts of their operations, and some of it will simply be shared to provide an accurate representation of priorities and issues identified. The reporting in this document does not utilize direct quotes; rather, it represents the efforts of the project team to develop a cohesive narrative that summarizes the wide range of information received.



02 What We Did



2.1 Introduction

Gathering input from municipal staff, residents and stakeholders is critical in order to identify the key issues and opportunities of a community. Recognizing this, the project began with an Engagement Strategy Meeting followed by an extensive formative engagement process. The project team hosted a series of engagement activities between September and December 2023, where participants were invited to share their perspectives and insights on land use and their vision for the future of Pictou County.

To ensure that the findings represent the diverse population of Pictou County, multiple methods of engagement were used, including:

- » The Project Website
- » Stakeholder Engagement
- » Municipal Council and Planning Advisory Committee Engagement
- » In-person Community Meetings
- » Online Community Meeting
- » Interactive Mapping Activity
- » Public Survey

These activities were promoted through the following channels:

- » The Municipality's website and social media
- » The project website
- » The Municipality's newsletter, which is mailed to civic addresses throughout the municipality
- » Direct emails and phone calls to identified stakeholders and those who requested project updates

2.2 Project Website

To kick off engagement, the Imagine MOPC website was established (www.imaginemopc. ca) to serve as a centralized hub for project information and updates. The website was first promoted during the project launch, which was advertised using various platforms including the Municipality's website, Facebook page, and newsletter.

The website provided the public with information about the project while encouraging participation in engagement activities. The website also offered an option for those interested to subscribe to a mailing list to receive updates on project events and milestones. Alternatively, participants were invited to contact the project team using the submission form on the project website. In total, the project website had 913 visits and 740 unique users as of December, 2023.



2.3 Municipal Council and Staff Engagement

The project team met with the Municipal Council at the outset of the project, on April 24th, 2023. This engagement session served as an opportunity to introduce the project, its goals, and UPLAND's approach to members of Staff and Council, and to gather their input and feedback. We learned about the history of planning work in the community, including an attempt to introduce planning in the 1960s, and the planning issues affecting residents today. This project marks the first time comprehensive land use planning will be adopted in MOPC. This engagement session allowed Council the opportunity to ask questions and share any concerns about the process and to learn more about the importance of planning and the risks associated with no planning regulations.

We reconvened with Staff, Council, and the Planning Advisory Committee during the initial phase of consultation on October 4th, 2023 in Council Chambers. This meeting provided a platform to discuss the preliminary feedback received from residents and to dive deeper into topics such as housing, agriculture, the environment, community character, economic development, and recreation. It also served as an additional opportunity to address any questions pertaining to the planning process and allowed the Council to thoroughly review the public engagement materials in preparation for upcoming community engagement sessions.

2.4 Stakeholder Engagement

Upon the project launch, approximately 30 stakeholders were identified to participate in various engagement activities. An email was sent to each stakeholder, presenting them with a comprehensive project overview and extending an invitation to partake in an online discussion. These sessions served as a platform for participants to deliberate on their project priorities, delve into pertinent issues, and explore potential solutions/opportunities. Participants were also allotted time to pose questions about the project. In total, 8 individuals actively engaged in an online discussion, providing invaluable feedback on subjects including, but not limited to, agriculture, economic development, recreation, youth, and the environment.

2.5 In-person Community Meetings

Throughout the month of October, six in-person community meetings were held across the Municipality. The primary objectives about these sessions were to foster awareness about the project, provide education to the public regarding the significance of planning, and answer questions from the public. The in-person sessions were dispersed throughout the municipality, and in total 107 community members participated.



2.6 Online Community Meeting

An online community meeting was held on November 1 for individuals who missed or were unable to attend any of the in-person community meetings. A recording of the session was also shared publicly for those interested in participating through this format. In total, 12 community members attended the live session, and the recording has 26 views as of December, 2023.

2.7 Interactive Mapping Activity

The online interactive map invited residents and stakeholders to input location-specific comments on a map of Pictou County and explore comments contributed by other participants. The map displayed existing zoning/ land uses and prompted discussion on existing conditions, preferred and disliked locations, and ideas for the future. This engagement platform welcomed participation from late September to late November, and throughout that period, the map received a total of 2 comments.

2.8 Public Survey

The public survey focused on identifying development goals and community ambition as it related to planning and development. It focused on planning issues relevant to the community, offering participants an opportunity to share their vision for the future of Pictou County with the project team. The survey was open for online participation from late September to late November, with paper copies and phone-in survey participation available upon request.

Altogether, 179 respondents contributed, each offering unique insights and perspectives on various facets of their community or Pictou County as a whole. Snapshots of the survey will be shared throughout the report, and the complete survey can be accessed in the Appendix.



2.9 Survey Participants

Effectively interpreting survey results requires understanding the degree of representation the survey sample holds in relation to the general population. Samples should mirror the demographic characteristics of a population, encompassing factors such as age, gender identity, and income. The project team utilized Statistics Canada 2021 Census data (the most current data available) as a benchmark, comparing it to the Public Survey results. This comparison aids in discerning how well the survey sample aligns with the community's profile. This step is crucial as it enables the identification of groups that might be underrepresented in the survey but are integral to the diverse fabric of Pictou County.




Fig 1. Age distribution of survey participants compared to 2021 Census

Fig 2. Gender distribution of survey participants compared to 2021 Census






Fig 3. Income of survey participants compared to 2021 Census





Fig 4. Survey responses to "Do you identify as a member of any of the following equity-deserving groups? Select all that apply."








Fig 6. Survey responses to "What kind of resident are you?"






Fig 7. Survey responses to "How long have you lived in Pictou County?"





Fig 8. Survey responses to "How many people are in your household, including you?





What We Heard

Fig 8. Survey responses to "What makes Pictou County a great place to live?"






Fig 9. Survey responses to: *"What are the challenges of living in Pictou County? Select all that apply.*







Fig 10. Survey responses to "*How important is it that the Municipal Planning Strategy addresses the following challenges?*





3.2 Community Character and Cohesion

"In 10 years, I want to see all towns thriving, growing and moving forward with what works staying, getting rid of the things that don't, and continue being a place we are proud to live in."



When prompted to describe the character of Pictou County in three words, survey respondents predominantly conveyed positive sentiments, using descriptors such as "friendly", "peaceful" and "beautiful". However, it is noteworthy that a subset of respondents offered a distinct perspective, using terms like "lacking" and "outdated". Numerous recurring comments relating to community character were brought to the forefront during consultation, and these will be explored in greater detail throughout this section.

Rural and Small Town Atmosphere

When respondents were asked about the factors that make Pictou County an exceptional place to live, "rural atmosphere" and "small-town atmosphere" emerged as two of the top five public survey responses. This theme remained consistent across engagement methods, with participants consistently emphasizing the importance of preserving the region's unique character while promoting forward-thinking and appropriate development. Participants reiterated the importance of adopting a balanced approach that achieves vibrancy without compromising the rural charm and lifestyle that define their community.

Residents also stress the importance of ensuring that, as the county develops, activities associated with rural living, such as the spreading of manure or the use of off-road vehicles, remain protected and free from regulation. Participants expressed concern that new residents may harbour unrealistic expectations about rural living, potentially leading to conflict between neighbors. Consequently, there is a shared desire to see more proactive efforts directed toward addressing this challenge.





A County for Everyone

While Pictou County is viewed by many as a desirable place to live, there is a consensus that a more profound and more thoughtful approach is required to make it an inclusive county for everyone. Participants believe that a county characterized by strong community cohesion is one that fosters a welcoming and progressive atmosphere while celebrating diversity. There is a collective desire for an increase in opportunities for residents to strengthen their social connections and sense of belonging through programming and improved community gathering spaces.

Concerns were raised about residents facing challenges in integrating into their community, with some even experiencing discrimination and other forms of mistreatment from neighbors. Additionally, participants underscored the need for enhanced support for under-served communities. It was emphasized that ensuring equitable access to municipal programs and services is crucial, as well as addressing issues related to housing, mental health, and isolation. Furthermore, participants called for increased support for entrepreneurs and artists of all backgrounds, along with targeted programming for residents of all ages.

Additional recurring recommendations offered by participants include:

- » Design spaces and places that are accessible and inclusive to all.
- » Tackle issues related to food insecurity, and encourage residents to grow their own food.
- » Increased number of community events.
- » Improve access to mental health support and other social services.
- » Foster the establishment of diverse businesses and programs.
- » More effective measures to address issues related to discrimination and exclusion.
- » Introduce more programs for targeted audiences, while also creating opportunities for residents of all ages and experiences to come together.
- » Address issues that contribute to residents feeling unsafe in their own community.



3.3 Agriculture

"In 10 years I want Pictou County to be a hub of agriculture in Nova Scotia"



Agriculture was raised across engagement methods as a vitally important part of the fabric of Pictou County. From cattle to soybeans, dairy products to lavender, MOPC was described as a strong farming community with many citing the largely rural nature of the municipality as what drew them to settle in the area. However, there were also concerns about a decline in the number of active farms.

The survey asked residents to what extent they were satisfied with Pictou County as a place to operate a farm or homestead, and the vast majority of respondents who had experience with this lifestyle said that they were either strongly satisfied (19%) or somewhat satisfied (40%). Only 12% of respondents said they were somewhat dissatisfied, and another 8% said they were strongly dissatisfied - the remainder were neither satisfied or dissatisfied with the area as a place to practice agriculture.




Fig 12. Public Survey Snapshot

To what extent are you satisfied with Pictou County as a place to operate a farm or homestead?

Farming has a long history in the area, but we heard concern from some working in the agricultural sector about encroaching development and a lack of protection for agricultural lands. With many people migrating out of cities and into rural areas in recent years, there has been a rise in land use conflicts in some rural communities, including MOPC. Some of this is caused by people moving to rural communities in search of "peace and quiet" without considering some of the other aspects of rural life, such as noise and smells from agricultural or other resource-based industries. This can result in disputes between neighbours and can have negative impacts on the quality of life for everyone involved. Most members of the farming community that we spoke to were interested in examining the ways that this could be mitigated through land use planning, as well as how planning can help to slow or curb the loss of agricultural land to development. We also heard concerns from farmers about the rising costs of land in rural areas and worry that the influx of residents buying properties at premium prices is impacting the ability of farmers to expand or start new operations. There is concern that they are being priced out of the land market altogether and that this could have widespread impacts on local food security. With many older farmers retiring, there is concern about new farmers being able to raise the capital to buy or start new farming operations in the community.



We also heard concerns about the impact that other resource sectors can have on agriculture. One farmer we heard voiced concerns about industrial scale wind turbine development and mining as threats to the viability of agriculture in their community due to potential impacts on groundwater (in the case of mining). It was suggested that incompatible land uses that have the ability to negatively impact soil and water quality should not be permitted on arable land.

When asked what they would like to see in terms of protection for agricultural land, we heard that there is a desire to have some level of protection in place. There was a recognition that agricultural land is not a "renewable resource" and that when it is lost it can have long lasting consequences on a community's ability to sustain itself. We also heard that this need for protection also needs to be tempered with the ability of farmers to sustain themselves and their families. For many farmers, their land is their greatest asset and some have plans to subdivide or sell lots to finance retirement, or supplement income when they experience a hard year. We also heard from farmers that they do not want regulations that impact their ability to make their own decisions about their farms and what they need - for example, if they require another barn or shed to be built, they want to be able to build that without having to undergo a long or arduous process. They noted that farming is a challenging industry and they do not want land use planning regulations that make it even more difficult for their operations.

We heard that agritourism is an important part of the local economy and that the new planning documents should support the growth of this sector and consider the needs of businesses when developing regulations in the Land Use Bylaw, such as retail, tap/tasting rooms, accommodations, and food service establishments. There is some concern that the introduction of regulations could impede economic development in the agritourism sector and operators want to ensure these are considered when drafting the planning documents.

We heard from farmers that they believe more agricultural operators should be engaged in this process, especially since they do not have an active local organization representing their interests (i.e. no local chapter of the Nova Scotia Federation of Agriculture). They would like to be given another opportunity to participate during the draft engagement period and expressed the importance of finding time when they can fully engage with the process - such as later in the winter when there are less demands on their time.





3.4 Housing

When survey participants were asked to identify the most important challenge for the Municipal Planning Strategy to address, "housing availability" and "housing affordability" both landed in the top five responses.



Across engagement methods it became clear that residents and stakeholders in Pictou County are grappling with a multitude of concerns related to housing. It was reported that rental options are limited, and the acquisition of housing poses challenges. Issues with homeownership appear to be disproportionately affecting young people entering the housing market, as well as seniors looking to transition into housing options that accommodate their changing needs. Furthermore, residents expressed concerns regarding tax structures and property assessments.

Recurring recommendations related to housing from participants include:

- » Address housing challenges while preserving the character of neighborhoods.
- » Provide a diverse range of housing options to meet the varied needs of all residents.
- » Support the development of sustainable housing initiatives.
- » Ensure there is adequate support in place for those requiring shelter in emergency situations.
- » Increase reach of municipal servicing to facilitate further development.
- » Control rent prices and protect renters from unfair treatment.
- » Restore vacant buildings for housing development
- » Provide financial assistance to property developers.
- » Permit accessory dwelling units on residential properties.
- » Implement programs that support homeowners facing barriers related to home maintenance (e.g. snow removal).
- » Offer short term options for those who are currently unhoused until long term solutions are established.
- » Acknowledge and understand the multidimensional impact that housing needs have on the community.




Fig 14. Survey responses to "Which of the following housing issues are relevant to your rental experience in Pictou County? Select all that apply."







Fig 15. Survey responses to "Which of the following housing issues are relevant to your home ownership experience in Pictou? Select all that apply."

Fig 16. Survey responses to "*Please rank the following approaches for increasing housing availability or affordability over the coming years*?"





Fig 17. Survey responses to: *"To what extent are you satisfied with Pictou County as a place to own a seasonal residence?"*





3.5 Economic Development

"In 10 years, I want Pictou to a place where people can access any services they need and a location with diverse employment opportunities across all sectors."




Across engagement methods, participants voiced a range of concerns related to economic development, highlighting mixed sentiments about the potential in MOPC. Recurring themes include a shortage of skilled trades and a desire for more diverse job opportunities, reflecting the community's aspirations for a well-rounded workforce. The closure of the Pulp Mill was a significant topic, generating mixed views on whether it was the right decision and highlighting its impact on the community. Additionally, there was a consensus on the importance of attracting and retaining young people to ensure the area's vitality. Striking a balance between industry and sustainable growth was emphasized, with calls for better support for small businesses echoing throughout. Notably, tourism emerged as a key aspect of economic development, with a collective desire for family-friendly attractions to enhance the region's appeal and contribute to its economic prosperity.

Recurring recommendations related to economic development from participants include:

- » Encourage vibrant downtown areas to attract new residents and visitors.
- » Promote a balanced economy and support the start up of diverse businesses.
- » Ensure commercial development is compatible with surrounding land uses and is supported by transportation facilities, including parking and active transportation routes.
- » Encourage greater density and mixed-use development.
- » Increase the diversity of ethnic food options.
- » Provide equitable and meaningful employment opportunities for all.

3.6 Environment

"In 10 years, I want Pictou to be a hub of green technology and a leader in environmental and small farming renewal"



Participants in Pictou County conveyed a collective desire for an environmentally friendly and sustainable community. While opinions varied on the prioritization of environmental issues in relation to overall community well-being, there was a strong advocacy for the protection of nature, particularly emphasizing beaches and sensitive environments. Coastal issues were frequently discussed during engagement sessions, with many participants expressing a desire for a proactive approach. Additionally, the importance of environmentally friendly industries, development projects, and tourism initiatives was highlighted. The prevailing sentiment was a desire for a balanced approach that effectively addresses environmental concerns while safeguarding the health and prosperity of individuals and the community as a whole.

Recurring recommendations made by participants regarding the environment include:

- » Encourage sustainable and ecologically responsible development
- » Protect the quality of soil, air, and drinking water
- » Ensure that tourism pursuits do not negatively impact the environment, rather enhance it
- » Conserve and protect natural spaces
- » Prepare and plan for climate change
- » Reduce greenhouse gas emissions and explore renewable energy options
- » Become a hub for green technology and other environmentally friendly industries
- » Implements a plan for flood protection, especially as weather events intensify, and sea levels rise
- » Protect remaining arable and natural lands from expansive development
- » Invest in active transportation infrastructure
- » Promote growing and buying local produce
- » Offer programming that encourages environmental education and knowledge sharing
- » Make better use of reclaimed mining land
- » Require mandatory water run off impact assessments for new development





3.7 Transportation

"Making transportation more affordable and public would do wonders to grow our rural communities."



Transportation emerged not only as an independent concern, but also consistently surfaced in discussions about other topics such as housing or employment. Numerous individuals shared their experiences living in what they believe to be a car-centric community, and as the municipality grows, there is a collective desire for improved and diversified transportation options.

The desire for improved public transportation options resonated strongly, with residents expressing a need for better travel connectivity both within MOPC and to other municipalities. Suggestions for enhancing public transportation ranged from small shuttles to a high-speed rail. Additionally, there was considerable interest in improving active transportation options in MOPC, and a desire for food delivery services to bolster demand for local restaurants. Overall, residents would like to see a transportation plan that aligns with the community's values of sustainability, accessibility, and inclusion.

Recurring recommendations from participants that relate to transportation include:

- » Consider the needs and desires of all transportation users
- » Focus on improving transportation options within the municipality while also addressing the need to travel outside of Pictou County
- » Improve active transportation infrastructure and amenities across the municipality
- » Implement speed bumps and other traffic calming measures in high traffic areas
- » Maintain routes in the winter months
- » Become a top tourism destination for cyclists
- » Increase bicycle parking options in key destinations
- » Improve wayfinding on trails and user friendly maps at trail heads

Active Transportation (sometimes referred to as "AT") encompasses all modes of humanpowered transportation. This includes walking and wheeling (referring to the use of assistive devices), cycling, skateboarding, as well as seasonal activities like kayaking, skiing, snowshoeing, and more. It also includes some motorized forms of transportation like e-bikes and electric wheelchairs. Some people depend on active transportation to get where they need to go due to lack of alternative transportation, while others choose to use active transportation as a preferred form of commute, exercise, recreation, or leisure.



3.8 Parks, Trails and Recreation

"In 10 years I want to see Pictou County continuing to expand while still keeping lots of green space."



When participants were asked what makes Pictou County a great place to live, "Access to Nature" claimed the top spot, with "Parks and Open Spaces" taking number five. Across engagement methods, participants consistently expressed high regard for outdoor spaces in the municipality and appreciated the ongoing efforts in maintaining these areas. We also heard about the variety of quality programs offered in Pictou County including but not limited to fitness classes and summer camps.

While many respondents commended the Municipality and other recreation providers for their work in facilitating and encouraging access to recreational opportunities, there was acknowledgment of areas for improvement, and the following recurring recommendations were shared:

- » Enhance access to trails and improve maintenance in winter months
- » Identify and collaborate with community organizations to ensure that recreation initiatives meet the needs of priority groups
- » Provide a facility, such as a dome, offering residents with the opportunity to engage in indoor sporting activities during the winter.
- » Introduce fishing programming and facilitate access to gear
- » Establish and maintain inviting public spaces that encourage physical activity and social interaction
- » Support the initiation of diverse recreation programs
- » Minimize barriers for individuals currently not participating in recreation
- » Promote inclusive recreation opportunities that bring individuals from all backgrounds together
- » Improve access to water based recreation activities



3.9 Resistance to Planning

"In 10 years, I want Pictou to be control-free from telling me what I can and can't do with my property"



Although the vast majority of residents who engaged with the process could see the benefits of planning, we did hear from a number of residents who were resistant to the introduction of planning in MOPC. Their concerns were primarily focused on the retention of rights on private property and the feeling that government should not be able to tell private land owners what do on their property. Some were open to the introduction of regulations that protect them from incompatible land uses in their community and were supportive of common-sense, defensible regulations, while others held fast to their belief that no rules should exist for private landowners.

At the public meetings, we heard multiple times about planning projects in other jurisdictions, especially a particular case in Alberta where stringent planning rules were brought in to a predominantly rural/suburban community. This example in particular made many residents we spoke with uneasy and, understandably, apprehensive about the project. They were concerned that the new planning documents would be heavy-handed and result in significant government overreach.

Recurring comments made by participants regarding resistance to planning include:

- » Skepticism of the intent of the process
- » The perception that the project is part of a larger global agenda with nefarious intent
- » A desire for the final documents to be flexible and not too heavy handed
- » Specific experiences that residents have had with the Municipality in the past, and the distrust they have with the government as a result
- » A desire for more transparency, improved service delivery, and consistency

- » Quality of roads and maintenance in the winter months
- » Challenges with cellular service and internet connection
- » Health care and social service shortcomings
- » Concerns about drugs and addiction
