Dr. Emmanuel,

Per your directive to remove the wall the department is currently seeking quotes for removal from the designer and installer, Eldorado Wall, along with contractors to provide a quote for the request. Councilman Gay did speak with me during legal review when reviewing the rock wall donation contract and expressed interest in looking to donating the wall to another entity along with our conversation that he expressed his interest in donating to a school in College Park. In order to donate the wall it would need to be preserved when removed and retrofitted for the new space. If the cost proposal is over \$10,000 it will need to follow the procurement process and be put out for bid and seek approval for the cost since this is not a budgeted item. The entities, Kai Lightner with Climbing for Change and Kevin Jorgeson with 1Climb, who provided the funding for the wall are vested partners and interest in the rock wall at the Wyatt Center.
