

Methodology	The poll was conducted telephonically, using a single frame, random digit-dialling sampling design. Briefly: The sampling frame consists of every potential cell phone number in existence in South Africa, from which a probability sample is drawn. This approach ensures that every number stands an equal chance of being included in the study, which is the most basic condition that must be met for survey results to be generalizable to the population from which a sample is drawn.

Weighting	The sample was fully demographically representative (weighted to ensure it aligns with all national demographic indicators: age, gender, language, race, rural/urban, income, education etc.)




Q: Do you believe Gender Based Violence, or GBV, and Rape are a problem in South Africa, or not a problem?




Q: Do you personally know of anyone who has been a victim of Gender Based Violence (or GBV) in South Africa, among your friends, colleagues or family?








I am now going to read you a brief description of what happened on 7 October 2023, and then ask you a few questions about it:

"At 6.30am on Saturday 7 October 2023, an estimated 3,000 rockets were fired Israel by Hamas militants from Gaza. Over 1000 armed Hamas militants stormed across the border into Israel and attacked a number of communities (kibbutzim) and hundreds of young people attending an all-night music festival. According to a statement by international legal experts, Hamas targeted their attacks against large numbers of civilians, committing murder, torture, rape, mutilation and molestation of bodies. They then took about 240 Israeli citizens hostage - including mothers, babies, small children and the elderly - and carried them across the Gaza border. About 1,200 people were killed on 7 October. Most of them were civilians, including Israelis, Israeli Arabs, Thai farm workers and citizens from other countries. Released hostages confirm that women still held captive are subject to ongoing sexual abuse."


Q: Which one of the following best describes your reaction to that description?




Q: Do you believe reports that women, girls and men were raped, tortured and sexually assaulted by Hamas militants?




Q: Which one of the following statements comes closest to describing what you believe about consequences for Hamas militants, if they did rape, torture and kill Israeli citizens?




