REQUEST FOR PROPOSALS

The Town of Caroline ('Owner') requests a proposal from your firm for construction services for reconstruction of stream stabilization structures in Six Mile Creek east of Banks Road (as per Plan Set 1393.004.003). The project will remove failed cross vane rock and reconstruct as a J-hook rock structure. Rock toe protection will be installed along 180' of the stream. Eight hundred seventeen (817) feet of streambed and bank will be regraded; stream banks will be regraded to a 3:1 slope.

Before submitting the proposal, it is the responsibility of the Contractor to visit the site and become familiar with and be satisfied as to the general, local, and site conditions that may affect cost, progress, and performance of the services.

Insurance/Indemnification Requirements

The proposal must take into account and satisfactorily provide that:

1. To the maximum extent allowed by law, the Owner, its officers, agents, and employees shall be indemnified against and held harmless with respect to any and all liability, claims, causes of action, demands and expenses (including attorney's fees) for or concerning personal injury (including wrongful death) or property damage arising out of or in any manner incidental or relating to the performance of any work or services under the agreement to provide any of the scope of services described in this request for proposals.
2. At all times throughout the project and so long as the Agreement is in effect, you will maintain in such limits and with such insurer(s) as the Owner deems satisfactory, the following insurance:
 - a. Comprehensive Commercial General Liability (with contractual liability coverage) of not less than \$1,000,000 each occurrence and \$2,000,000 annual aggregate; and,
 - b. Commercial Automobile Liability with limits of at least \$1,000,000 each accident and must include coverage for liability arising out of all owned, leased, hired, and non-owned automobiles; and,
 - c. Contractor Contractual Liability; and,
 - d. Commercial Umbrella with limits of at least \$5,000,000; umbrella coverage must include all additional insureds on the CGL. Umbrella coverage for additional insureds shall apply as primary before any other insurance or self-insurance, including any deductible, maintained by, or provided to, the additional insureds other than the CGL, Auto Liability, and Employer's Liability coverages maintained by the Contractor/Subcontractor. The policy may not contain any exclusions relating to NY Labor Law or municipal work.
 - e. Owner's and Contractor's Professional Liability with limits not less than \$1,000,000 each occurrence and \$2,000,000 annual aggregate; and,
 - f. Workers Compensation and Employee's Liability (statutory amount).

Each policy of insurance shall be from a carrier acceptable to the Owner, shall name the Owner, the Engineer, and all other parties required of the Contractor as "additional insured" and provide that it may not be materially altered, suspended or cancelled without sufficient advance notice to such effect first being provided to the Owner.

Prevailing Wage

This project is subject to prevailing wage requirements under Section 220 of the New York Labor Law. The PRC # for this project is: 2024006079
