- I understand that a previous criminal conviction may require additional safeguards be put in place that may impact on my ability to serve in a specific area of church life.
- I agree to cooperate with the relevant authorities, including Baptist Churches of South Australia (BCSA) in any investigation undertaken in relation to Gateway Church
- I understand that although I may not work directly with children, their protection is of paramount concern. I acknowledge I have read and agreed to the Gateway Child Protection Policy and will follow its guidelines.

- I have read, understood, and agree to the Gateway Standards of Conduct.
- I acknowledge the Statement of Faith and accept that Gateway believes in and upholds the beliefs outlined in it.
