

# Privacy Policy for GAIN Sweden

GAIN Sweden ("we," "our," or "us") is committed to protecting your privacy. This Privacy Policy outlines how we collect, use, and protect your personal data when you visit our website ([gainsweden.org](https://gainsweden.org)) or engage with our services. As a Swedish non-profit organization, we comply with the General Data Protection Regulation (GDPR).

## 1. Information We Collect

We collect and process the following types of personal data:

- **Cookie Data:**\*\* Information collected via cookies to enhance your browsing experience and gather analytics about website usage.
- **Contact Information:**\*\* Personal data such as your name, email address, and any other information you provide when signing up for newsletters or contacting us through digital forms.

## 2. How We Use Your Data

We use your personal data for the following purposes:

- To improve and personalize your experience on our website.
- To send newsletters and other communications you have subscribed to.
- To respond to inquiries and provide requested services.
- To analyze website performance and user interactions for marketing and service enhancement.

## 3. Sharing of Data

- Deletion: Request the deletion of your personal data, subject to certain legal obligations.
- Objection: Object to the processing of your data for specific purposes.
- Data Portability: Request a copy of your data in a structured, commonly used, and machine-readable format.
- Withdraw Consent: Withdraw your consent for data processing where applicable.
