# Honouring Palestine. A Vigil for the Victims of the Gaza Genocide.

On 7 October 2025, the Palestinian community of Victoria will hold a peaceful public vigil to honour our loved ones killed by Israel, and to bring into the light what has too often been demonised and forced into silence: our grief, our humanity, and our right to survive. We invite all people of conscience to join us in truth and compassion, affirming that mourning is a universal human right.

For 77 years, Palestinians have lived under violent dispossession, apartheid, and illegal occupation.

Our grief has been erased. Our resistance demonised and criminalised. Our humanity denied.

Since 1967, Gaza has been a prison under Israeli control. Even after the so-called 2005 "withdrawal," Israel retained control over our borders, airspace, sea, population registry, and trade. Since 2007, Gaza has endured a suffocating blockade and relentless bombardments, killing Palestinians with impunity.

Yet western governments, institutions and media turned a blind eye, exposing the double standards in how Palestinian lives are valued - in stark contrast to the outrage over 7 October, 2023.

On that day, Hamas fighters breached the prison fence confining the Gaza Strip in an unprecedented large-scale assault. People died. Reports also indicate the Israeli military invoked the Hannibal Directive - a protocol permitting extreme measures to prevent abductions, even at the risk of hostages' lives. Meanwhile, 250 hostages were taken into Gaza, with Hamas stating their goal was to negotiate for the release of thousands of Palestinians held in Israeli prisons, many without trial.

That same night, Israel unleashed a massive bombardment on Gaza. Despite claims that no such attack took place, Amnesty International documented the destruction and deaths in those first days.

Between 7 and 22 October, more than 3,793 people were killed, mostly civilians, including over 1,500 children. At least 12,500 Palestinians were injured, and over 1,000 bodies remained trapped under the rubble. In the narrow window of 7 to 12 October alone, Amnesty verified thousands of Israeli airstrikes that levelled residential neighbourhoods and killed Palestinian civilians.

Entire multigenerational families were wiped out. By mid-October, at least 47 Palestinian families had been permanently erased from the civil registry in Gaza. These facts are a matter of public record. To deny them is to deny the truth, and to deny the humanity of those killed.

From 7 October 2023, Israel chose to prosecute a full-blown genocidal campaign against the Palestinian people, which mainstream media and political leaders obscured under the guise of self-defence. Entire neighbourhoods in Gaza were reduced to rubble. Tens of thousands of civilians were slaughtered by airstrikes and sniper fire. Children were starved, orphaned, and maimed. Women were denied safe childbirth, sexually assaulted, and left to bleed to death. Men were tortured, raped, and sexually assaulted in Israeli prisons. Some were bound as human shields to tanks, others trampled and killed beneath them.

A man-made famine was imposed, with starving Palestinians shot and killed as they tried to reach food and water under the so-called US-Israeli "GHF" scheme. Emergency workers and medical staff were executed and buried in shallow graves. Palestinian journalists were deliberately targeted and killed, without so much as a whimper of protest from mainstream media colleagues worldwide

Gaza has become a place where children are executed by sniper fire, burned alive, or buried under rubble; where infants are decapitated; where bodies are riddled with over 350 bullets - all met with silence from the media and from world leaders who claim to stand for civilisation, human rights, and compassion.

Yet we, the Palestinian community, stand steadfast in the face of the relentless dehumanisation and demonisation of our people and our children.

Despite its long history of belligerent occupation, persecution, and the slaughter of Palestinian civilians, Israel is celebrated by Western politicians and media as "the only democracy in the region" - even as it wages a barbaric genocide in plain sight.

The ICJ has ruled Israel's occupation unlawful. The UN General Assembly has demanded Israel's withdrawal from all occupied territories by September 2025. The UN Commission of Inquiry, along with other international bodies, has declared Israel guilty of genocide.

Entire neighbourhoods have been flattened. Over 80% of Gaza has been reduced to rubble. Homes, hospitals, schools, universities, farmland, and cultural institutions have been systematically targeted - nothing of civilian life spared. Israel has imposed, and continues to maintain, a famine on the entire civilian population of Gaza, and continues to attack humanitarian aid workers in Gaza and in international waters. Children, journalists, medics, and aid workers, including Australian Zomi Frankcom, have been massacred with complete impunity. The majority (83%) of the Israeli civilian population openly support the genocide and ethnic cleansing of the Palestinian people. Israeli and US officials have publicly voiced genocidal intent, boasting of "erasing" Gaza's people and redeveloping its shattered, bloodsoaked land into luxury beachfront property. Israel's leaders stand accused of war crimes and crimes against humanity.

Meanwhile, in the West Bank, Israeli settlers attack Palestinians, and steal their land and homes with impunity, while the state passes laws to annex what little Palestinian-owned territory remains, advancing Israel's vision of a fully ethno-national state. Yet through it all, Australia and other Western powers grant Israel impunity, preserving trade, research partnerships, and diplomatic ties, so long as the bodies destroyed are Muslim, Palestinian, Arab, Black, or brown.

All the while, Palestinians in Australia are told not to "import our conflict here," even as the government approves export permits and signs defence contracts with Israeli arms companies. These firms openly advertise their weapons as "battle-tested" on Palestinian bodies.

One such company is Israel's state-owned Rafael Advanced Defense Systems, which has signed contracts and joint ventures directly with the Australian Defence Force. It has even used footage of a Palestinian man killed by its weapons as promotional material. Australia's complicity runs deep. Components made here, which our Foreign Minister calls "non-lethal parts," are used in the very machines that massacre our loved ones in our ancestral homeland.

At the same time, accusations of antisemitism are too often weaponised to silence and persecute Palestinian and pro-Palestinian voices, and to pressure politicians, media, government agencies, and institutions. Under the guise of protecting "social cohesion" and public safety, lobbies, media, and politicians push for the censorship, erasure, and demonisation of Palestinians and their supporters, with government representatives, institutions, universities, and media all too willing to comply. The harm was compounded further a few days ago when the Prime Minister, once well aware of the suffering and colonial persecution faced by Palestinians, stood on the world stage and claimed we teach our children to hate.

These efforts stoke anti-Palestinian hatred and Islamophobia, working to silence our voice and erase our existence, even here. Palestinians are demonised in life and dehumanised in death. With the complicity of politicians, lobbyists, and the media, narratives are crafted to erase our identity and history, and minimise and justify the killing of our loved ones.

Last year, when our community gathered for a vigil on the first anniversary of October 7, we faced harsh public criticism. Prime Minister Albanese described the event as "provocative," choosing only to acknowledge the grief of the pro-Israeli community. Other public figures condemned it as a "celebration of hate and death." Some even denied that Israel bombed Gaza on October 7, despite evidence to the contrary.

New South Wales Premier Chris Minns called our vigil "hugely insensitive" to Jewish Australians for what he said was a lack of space for their mourning. Victorian Premier Jacinta Allan likewise described the vigil as "deeply inappropriate," implying, as she has consistently done when referring to Palestinian suffering and cries for freedom and justice, that it amounted to "hate speech" and "antisemitism." Yet neither leader, nor other politicians or media commentators, recognised the grief of the Palestinian community.

For Palestinians in Australia, already carrying unbearable loss and grief, these attacks on our right to grieve cut deeply. The lack of formal acknowledgement of our suffering, and the absence of political and religious representatives, has been heartbreaking. The media compounded this harm by mocking the vigil and focusing on controversy rather than the symbolism and message of abandonment we sought to convey. We kept an overnight wake on the steps of the Parliament, providing ample time for leaders to come and pay their respects. No one came. In moments like these, so-called Australia appears to embrace Israel's mission to erase Palestinian identity and presence from its own shores.

We acknowledge the loss and grief experienced by Israeli families and affirm their right, as with all people, to mourn. But Palestinians alone are denied that same right. Our grief has been silenced, dismissed, and criminalised.

While Israeli grief has been met with the sympathy of governments, religious institutions, and media, Palestinian grief has been dismissed, demonised and denied. Every Palestinian carries loss in this genocide, some mourning one loved one, others mourning over a hundred. And all of us carry, too, the grief of 77 years of colonial dispossession, persecution, expulsion, and the martyrdom (i.e., the violent death) of countless loved ones. Yet there has been no acknowledgement from government, no compassion from political leaders, and no recognition from religious institutions.

Still, we have been comforted by the compassion and solidarity of ordinary people across Australia. Their recognition of our grief and suffering has given our community solace in the face of such cruel abandonment.

Our rights are not conditional. Our humanity is not negotiable.

We mourn publicly because apathy and silence have been forced upon us. We stand in defiance because erasure and submission have been demanded. We refuse disappearance, we refuse subjugation.

The Palestinian people in Palestine and the diaspora, including in so-called Australia, are a proud and beautiful people, yearning to live in freedom, dignity, and security in their ancestral homeland. We reject dehumanisation. We teach our children to refuse tyranny and occupation, and to embrace love: for life, for justice, and for freedom.

Until this truth is honoured and this right protected, we will not be silenced. We will continue to resist every attempt to subjugate and erase us. We exist. We existed before 1947 on our ancestral homeland, and we will prevail, thriving for millennia to come on our homeland. Palestinian lives, like all lives, are precious and enduring. We have every right to live and thrive in freedom and safety on our ancestral homeland.

Whether in crowds or in solitude we grieve for our loved ones. All of our loved ones killed by Israel, all of our children, babies, women and men, even those whose bodies will never be recovered, deserve to be acknowledged and mourned.

At this vigil, we will gather peacefully and with dignity to honour our loved ones, to grieve openly, and to stand in truth. In silence and solidarity, we will connect through our shared humanity, bearing witness to lives that must be remembered, to grief that must no longer be erased, and to lives that must be protected and freed.

We call on all people of heart and conscience to support us in our grief, and to stand against the erasure of our humanity, identity, and history, and the denial of our suffering.

Join us on 7 October, 2025, for a public vigil in Naarm (Melbourne), and stand with us in grief, in dignity, and in recognition of our common humanity.
