Investigation of Connecticut's Registrars

A preliminary study on the legal compliance of Connecticut's registrars by town.

Chapter I: Executive Summary

- FVF, Inc. conducted an investigation regarding the compliance of town registrars with relevant state statutes which ensure elections are properly conducted by well-trained election officials.
- FVF, Inc. sent Freedom of Information Act requests to both the Connecticut Secretary of the State's Office and all 169 individual towns requesting the applicable data.
- The Connecticut Secretary of the State's Office failed to provide accurate and complete information requested by Fight Voter Fraud, Inc.
- Only twenty-nine cities/towns were completely compliant with the Freedom of Information Act requests sent by FVF, Inc.

Title 9, § 9-32 (Conn. Gen. Stat. § 9-32)-Canvas of voters (ED-632 form):

- Must be completed by May 1st.
- Sixty-four towns sent FVF, Inc. a properly conducted, on-time canvass.
- Forty-eight towns sent FVF, Inc. a canvass that was dated after May 1st.
- Fifty-seven towns refused to provide FVF, Inc. with a canvass report.

Title 9, § 9-192a of Connecticut General Statutes- Certification of Registrars

- After two years of taking office, all registrars must be certified.
- 147 registrars are certified.
- FVF, Inc. estimates forty-eight registrars are not certified.
- Fifty-seven registrars refused to provide a record of certification.
- Eighty-six registrars have taken office less than two years ago.

Title 9, § 9-192a of Connecticut General Statutes- Education Hours for Registrars

- Following certification, each registrar must complete at least eight hours of training every year.
- 177 registrars are in compliance with this statute
- Seventeen registrars are not in compliance with this statute.
- 144 registrars have refused to provide FVF with their education hours.

Chapter II: Explanation of Investigation

Since July, Fight Voter Fraud, Inc. (FVF, Inc.) has conducted an investigation regarding the certification of Registrars in the State of Connecticut. During this investigation, FVF, Inc. has uncovered numerous violations of multiple state statutes committed by registrars statewide. The proceeding report outlines the status of the registrars in every town, helping residents determine whether their registrars are in full compliance with relevant state statutes. This investigation will include all applicable documents requested by FVF, Inc. from each town, in accordance with the Freedom of Information Act (5 U.S.C. § 552)¹, also known as FOIA, as well as all communications exchanged between FVF, Inc. and the towns. The following provides an overview of the investigation to help the reader interpret the subsequent findings:

I. ED-632(Canvass Form):

According to Connecticut General Statutes, Title 9, § 9-32 (Conn. Gen. Stat. § 9-32)² “In each municipality the registrars, between January first and May first, annually shall cause either” a house-to-house canvass, a canvass using the National Change of Address System of the United States Postal Service (NCOA), a canvass by telephone, a canvass by mail, or a canvass using a variety of the aforementioned methods. The canvass process is necessary to maintain the accuracy and integrity of the voter rolls, ensuring only eligible voters are able to cast a ballot in that year’s election. FVF, Inc. is putting a copy of the completed canvass form sent from each town either from 2024 or 2023, depending on which year’s canvass FVF, Inc. has received, on fightvoterfraud.org. This allows constituents to check if their town’s canvass was completed properly and on time. **Note:** In order for a canvass document to be official, it must be completed, signed, and dated by both the Republican and Democrat Registrar of each town.

II. Registrar Certificates

All registrars who took office after July 1, 2015 must be certified two years after beginning the position. The certification process requires the successful completion of a twenty-five-hour course proctored by the University of Connecticut (UConn) that ensures each registrar is properly trained to run an election. Title 9, § 9-192a³ (Conn. Gen. Stat. § 9-192a) states “Any registrar taking such office after July 1, 2015, shall complete such program and satisfy such criteria for certification (A) in the case of a two-year term, not later than the conclusion of such term, and (B) in the case of a four-year term, not later than two years after the date of first holding such office”. In Connecticut, it is estimated forty-eight registrars are not compliant with this regulation.

This report will describe all records of registrar certifications FVF, Inc. has received. If one checks on fightvoterfraud.org and there are not two certifications for each town, one for the Republican Registrar and one for the Democrat Registrar, that means either (1) the town has not complied with FVF’s FOIA request, (2) the registrar had been hired less than two years ago and thus is exempt, or (3) the registrar has not been certified

in the time prescribed by the above statute. This report will indicate which of the three categories each registrar lacking certification belongs to.

To determine whether the registrar truly lacks certification or the town simply has not provided it, FVF, Inc. cross referenced the certification list provided by the secretary of the state with the records it received from each town through the FOIA. If the secretary of the state has listed the registrar as certified, but the town has not provided the certification, the registrar will be labeled as refusing to provide certification. However, if the secretary of the state has no record of the registrar's certification and the town has not provided FVF, Inc. with an official certification record that registrar will be labeled as not being certified. **Disclaimer:** FVF, Inc. has uncovered some inaccuracies in the data it has received from the Connecticut Secretary of the State's Office. Due to these inaccuracies, FVF, Inc. cannot confirm with absolute certainty the certification status of each registrar. This investigation gathers preliminary evidence so constituents have an idea of the status of their municipalities registrars. This investigation relies solely on government documents in presenting its findings.

Documents and email correspondence between FVF, Inc. and the Connecticut Secretary of the State's Office will be included in the data section (Chapter III). All other documents and communications between FVF, Inc. and each town will be available to view on fightvoterfraud.org.

III. Education Hours

Each registrar is responsible for completing required training hours each year following the completion of their certification. Title 9, § 9-192a (Conn. Gen. Stat. § 9-192a) specifies "each registrar [post-certification] shall participate each year in not less than eight hours of training". Moreover, Title 9, § 9-192b (Conn. Gen. Stat. § 9-192b)⁴ also articulates that "registrar of voters shall annually designate either said registrar, the deputy registrar of voters or an assistant registrar of voters to receive at least ten hours of instruction under the elections training program developed under subdivision (2) of subsection (d) of section 9-192a." FVF, Inc. has requested the records for the number of training hours each registrar has received annually since 2018. This report will verify whether each registrar has completed the required eight hours of annual training. **Note:** 2023 hours will be used in the write up of this report to check compliance of those registrars who have not yet received enough hours in 2024. All hours from 2018-2024 will be available to view on fightvoterfraud.org.

IV. Letters Sent by FVF, Inc. to Mayors, First Selectman, Town Attorneys, etc.

To ensure transparency, this investigation will include all cover letters FVF, Inc. sent to request the documents outlined in I, II, & III on fightvoterfraud.org.

V. Correspondences Between FVF, Inc. and City/Town Representatives

When beginning this project, FVF, Inc. had the expectation that all documents requested would be provided in a timely manner, in accordance with FOIA. Neither expectation has been met; multiple towns have provided FVF, Inc. with an incomplete

FOIA request and/or have completed the request after the allotted thirty-day period. To elucidate the difficulty FVF, Inc. has encountered in requesting these documents, and to establish transparency, all correspondences between FVF, Inc. and each town will be included on Fight Voter Fraud's website.

The goal of this investigation is to ensure every registrar is meeting the standards of excellence one expects from those tasked with running our elections. Furthermore, this study is meant to empower the citizens of each town to demand accountability from their election officials. Chapter III: Data:

The following section gives a visual overview of the data collected during this study. It will include bar-graphs related to the certification of each registrar, the status of the canvassing for each town, and the breakdown of the number of education hours received for all registrars across the state since 2018.

For the ED-632 form, the accompanying bar graph will display whether each individual town either (a) completed the document on time, for either 2024 or 2023, so is fully compliant, (b) completed the document late which is after May 1st, for either 2024 or 2023, or (c) did not send FVF, Inc. a copy of a completed canvassing report for 2024 or 2023.

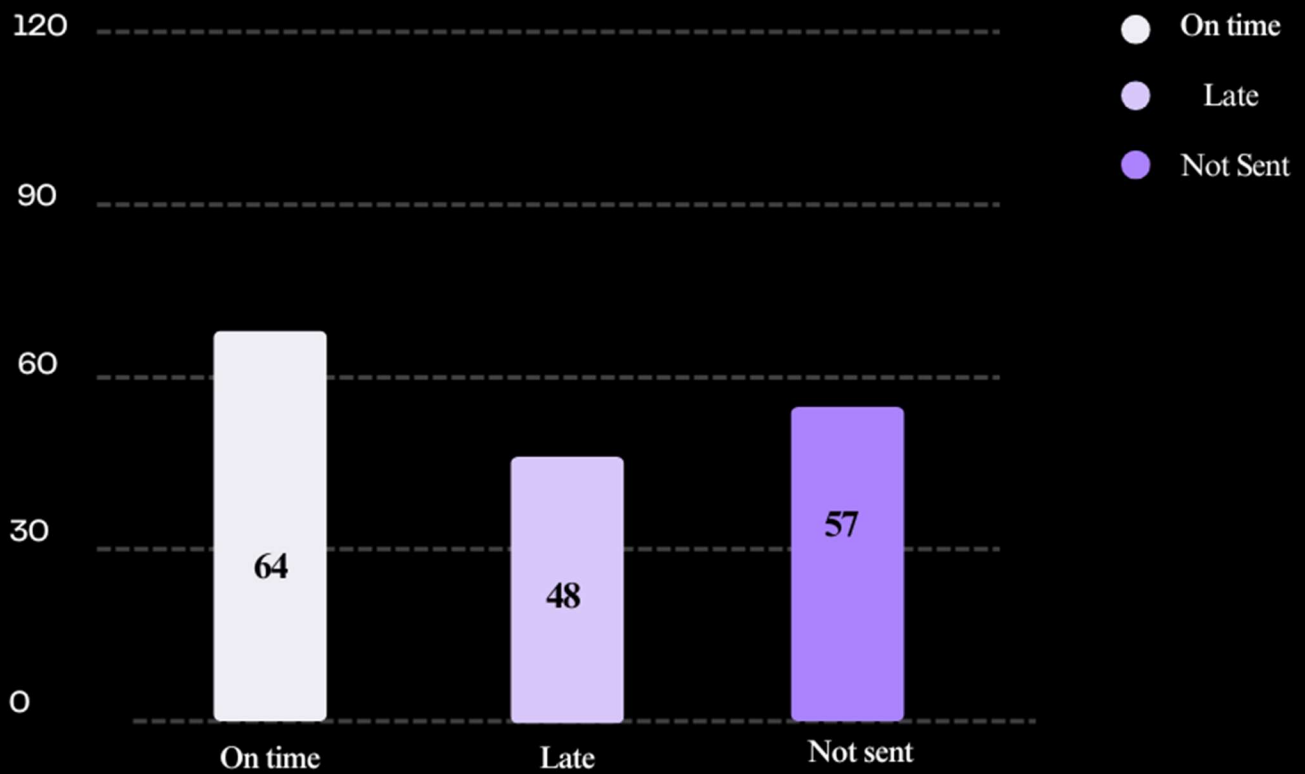
The bar graph that accompanies the registrar certifications will display whether each individual registrar either (a) is certified in compliance with Title 9, § 9-192a of Connecticut General Statutes, (b) is not certified and thus not in compliance with Title 9, § 9-192a of Connecticut General Statutes, or (c) began their initial term less than two years ago and therefore has time to obtain certification, or (d) is certified in compliance with Title 9, § 9-192a of Connecticut General Statutes but has refused to honor FVF, Inc.'s FOIA request to obtain a copy of their certificate.

The histogram that accompanies each year's education hours will display the breakdown of hours each registrar has received. It will break registrars into categories by every two hours (i.e. received 0-2 hours, 2-4 hours, 4-6 hours etc.). The vertical dashed red line on each histogram represents the state mandated number of education hours each registrar must receive annually. Those registrars that fall to the left of the red line are not compliant with state statutes, whereas those who fall to the right of the line are. It is worth noting, in addition to the mandated eight hours each registrar must receive, each town must designate either a registrar, an assistant registrar, or a deputy registrar to receive ten hours of instruction under 'the election training program' as prescribed by Title 9, § 9-192b of Connecticut General Statutes. Fight Voter Fraud, Inc. did not verify compliance with these education hours in this report. **Therefore, even if your particular registrar is compliant with their individual education hours, that does not necessarily mean the entire town is compliant with the election training program.**

The Connecticut Secretary of the States's Office sent an incomplete document regarding the certification status of each registrar. FVF, Inc will include this document along with the email correspondences between FVF, Inc. and the secretary of the state's office.

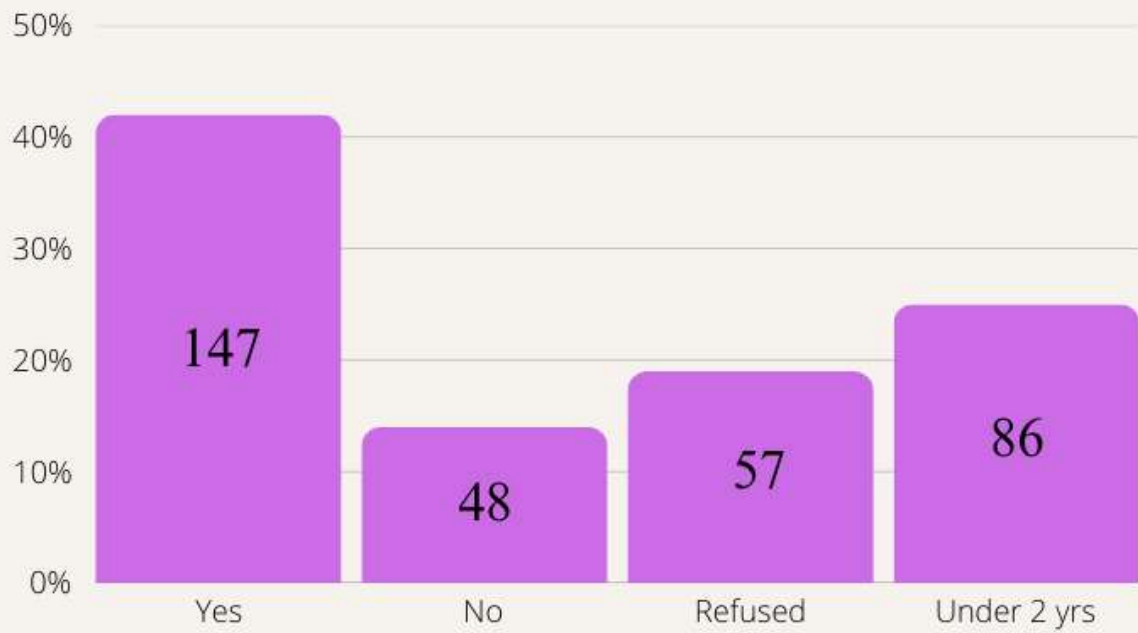

Registrar Certification

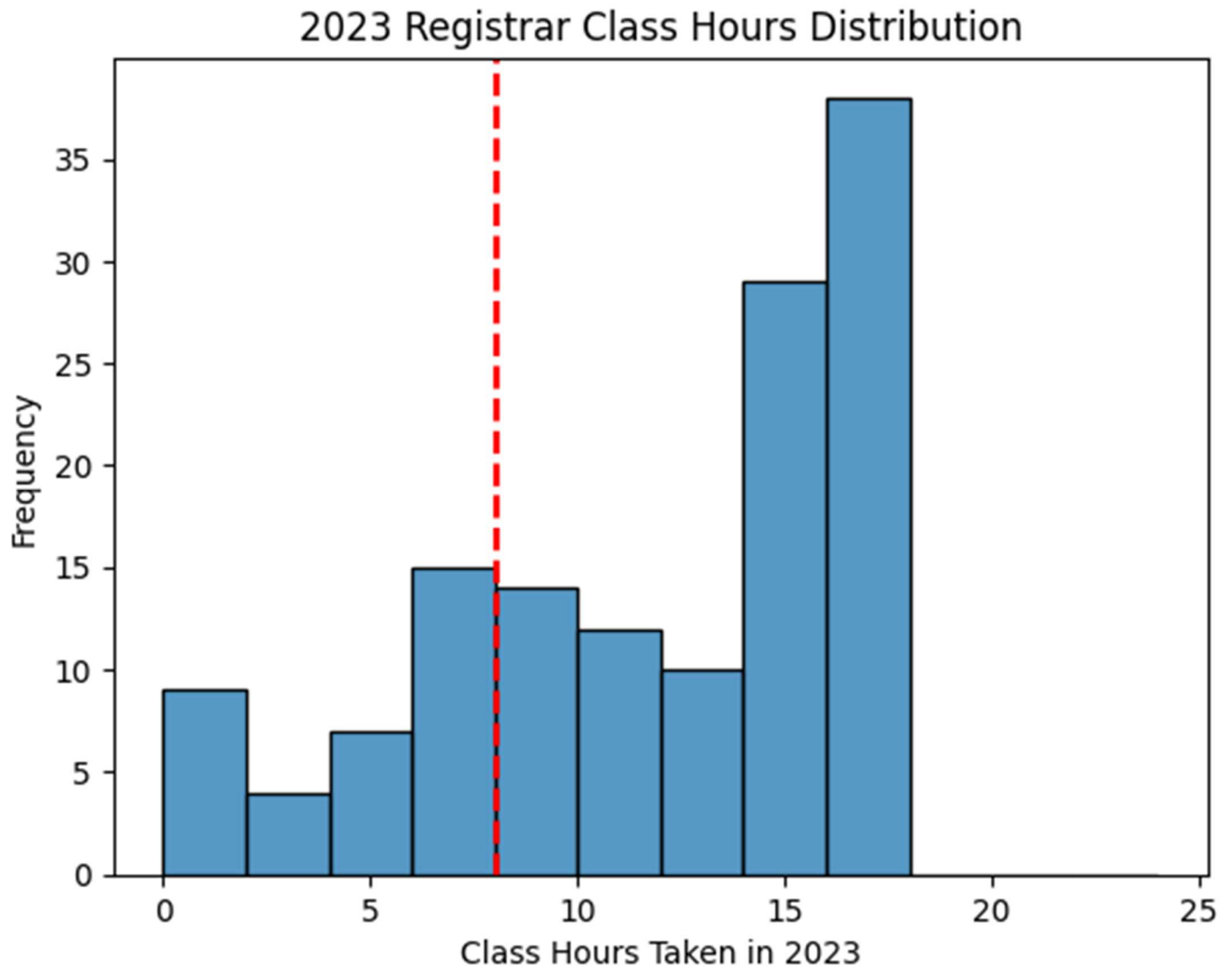
Are CT Registrars Certified?



Registrar Education Hours 2024



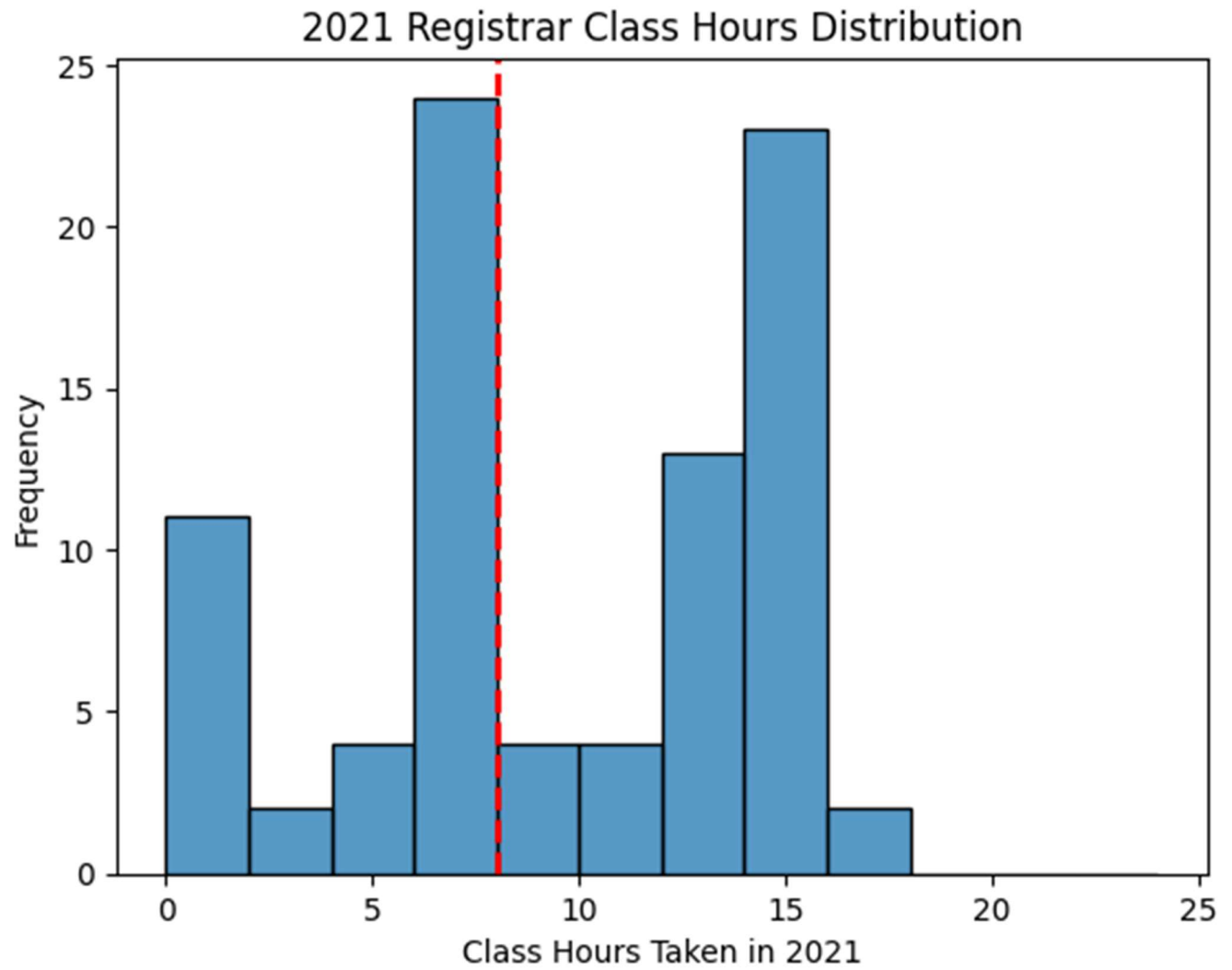
Registrar Education Hours 2023



Registrar Education Hours 2022



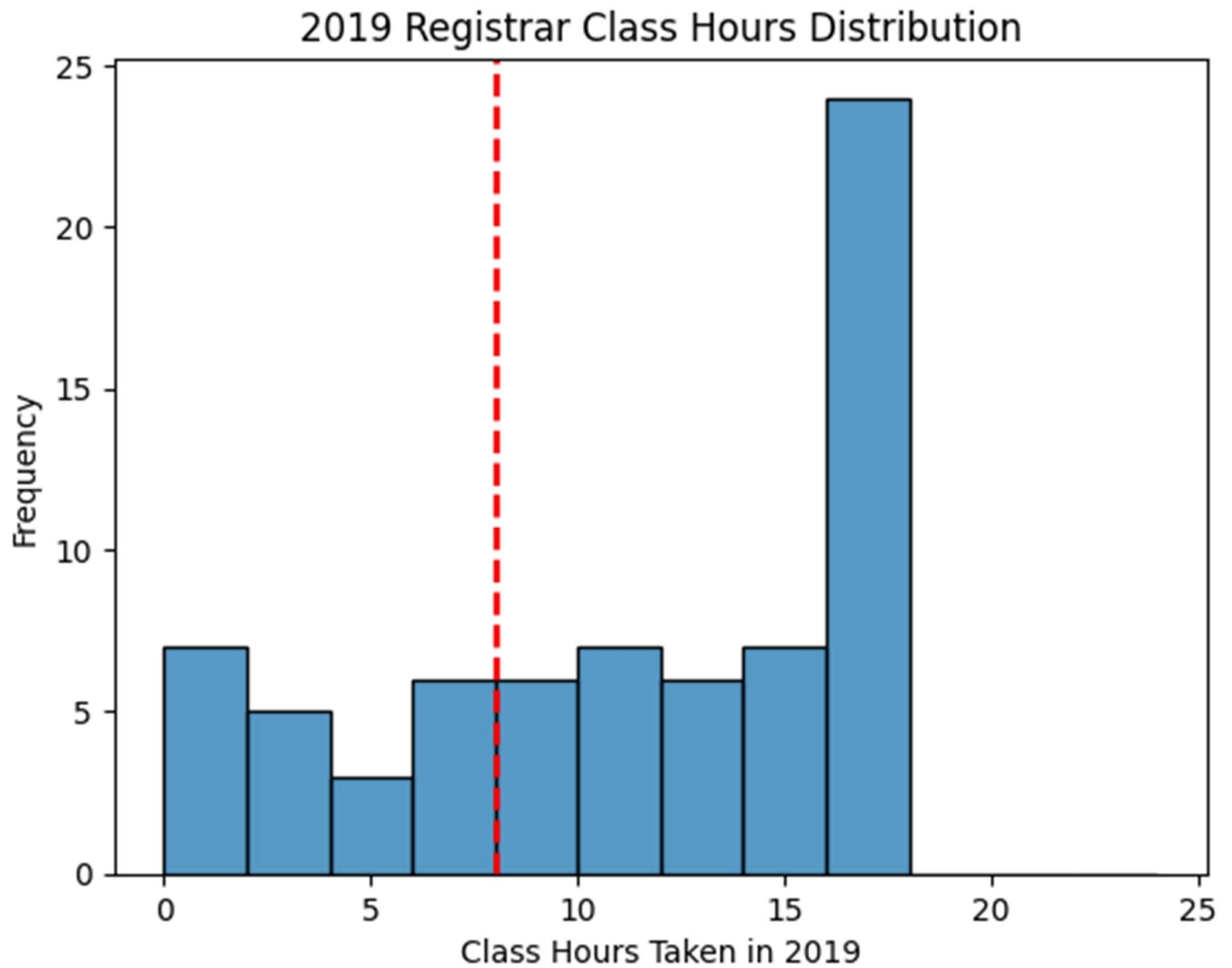
Registrar Education Hours 2021



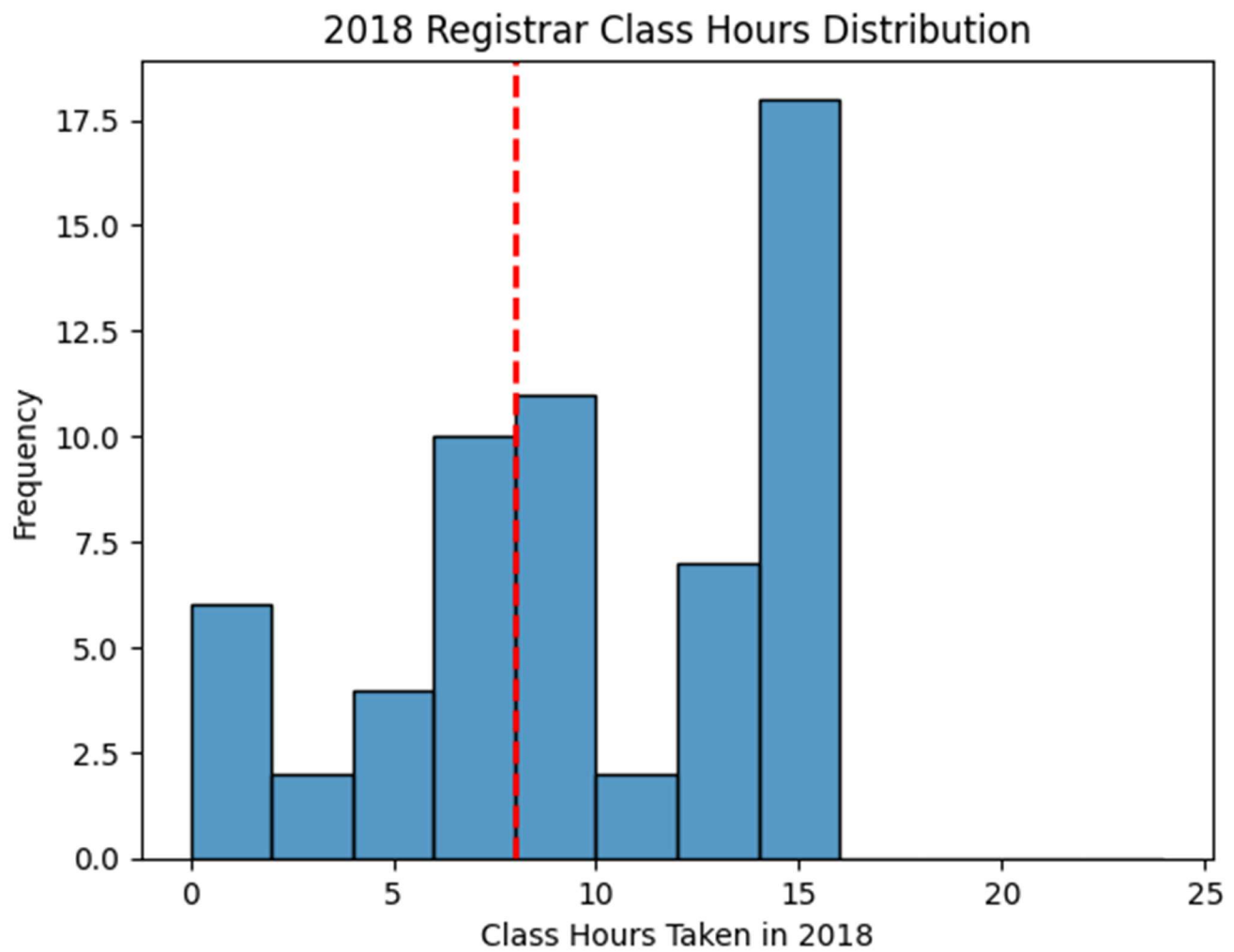
Registrar Education Hours 2020: *Note the COVID-19 pandemic appears to have impacted education hours for 2020*
