### Major 401(k) adoption deadlines

October 1, 2023 - Deadline to adopt a safe harbor 401(k) plan for 2023.

**December 2, 2023** - Deadline to adopt the amendment necessary to convert a normal 401(k) plan to a 3%.

**March 15, 2024** - Deadline for S-Corps and partnerships to adopt a normal 401(k) plan for 2023.

**April 15, 2024** - Deadline for C-Corps and sole proprietorships to adopt a normal 401(k) plan for 2023.
